# SEWER RATES



This schedule of rates and charges applies to **Evansville Water and Sewer Utility customers**, and supersedes previous schedules issued.

## BASE CHARGE

The **monthly service charge** is based on meter size.

## WATER-BASED CONSUMPTION CHARGES

These charges are based on the quantity of water used on or in the property or premises. Customers are charged two rates per 1,000 gallons — a rate for cost of services and a rate for the City’s consent decree with the U.S. Environmental Protection Agency (EPA). The EPA consent decree rate was effective Jan. 1, 2014, and is related to a federal mandate that the City of Evansville comply with the Clean Water Act. The charges are determined using the following rates schedule.

Residential*	Inside City	Outside City
Cost of service rate (per 1,000 gallons)	\$7.32	\$9.88
EPA consent decree rate (per 1,000 gallons)	\$2.01	\$2.70

\*Effective Jan. 1, 2013, the Town of Darmstadt receives a 30% reduction from the Outside City Public Authority rates. Please refer to Commercial/Industrial/Public Authority schedule of rates.

## PROPERTIES NOT USING UTILITY WATER

The following monthly rates apply to any lot, parcel of real estate, or building connected with, using, served by or benefiting from the City's sanitary service but not served by the City's waterworks.

### Unmetered User (assumes 8,000 gallons/month)

Inside City	\$83.04
Outside City	\$112.02

### Unmetered User — Reduced Rate (assumes 4,000 gallons/month)

A discounted rate is available to any property that is owner-occupied residential, and not more than two people reside thereon or therein, and a properly executed affidavit is on file with the Utility. The following monthly rates apply.

Inside City	\$45.72
Outside City	\$61.66

## TRASH AND RECYCLING (REFUSE) COLLECTION RATES AND CHARGES

Trash and recycling collection of refuse is available to residential structures with five or fewer units. A residential unit is defined as an occupied or unoccupied single-family residential dwelling unit. This includes each individual housekeeping, living or dwelling unit of a multi-family building. Multi-family units that have a trash dumpster on site may opt out of this service and have charges dropped.

(Pursuant to City Code Sections 8.05.070 and 8.05.090)

Monthly fee per residential unit	\$10.65
(Additional) Backdoor collection fee	\$2.00

## CONNECTION CHARGES

The charge shown is for a single-family house connection and applies to customers who do either of the following:

- Tap in to the sewer system that is either publicly or privately owned and that is either a part of the City sewer system or directly, indirectly or eventually extends to or flows into the City sewer system; or
- Add an improvement to an existing structure to which plumbing of any sort is extended.

This charge will be adjusted yearly as follows:

### Single family apartment or condominium\*

Current	\$1,800
7/1/17	\$2,000
7/1/18	\$2,100

\*Includes mobile homes, trailers, motor homes or other similar vehicular-type construction

### Multi-family properties per unit\*\*

Current	\$900
7/1/17	\$1,000
7/1/18	\$1,050

\*\*Apartments and townhomes.

## LATE PAYMENT FEE

Bills for sewer and trash and recycling service not paid before the stated due date are subject to a late payment fee of 10%.
