2) Summary of Industrial User Compliance

Status of IU Compliance (Summary) 2016

ARAMARK, Inc. discharged a "Slug" load on May 15, 2015. They discharged (275 gallons) of *Turbo Flex*, a commercial laundry detergent to their pretreatment system. The event was determined to cause a "pass through" and "interference" occurrence. On June 23, 2015 an Administrative Compliance Order was issued. The details of this event are more specifically defined in the "Administrative Compliance Order" that was submitted with the 2015 second quarter report. A total of \$23,019.81 was levied against Aramark for this incident. This fine payment of \$23,019.81 was posted to a City account on July 16, 2015. A contract certified operator was hired to make visits to the site three times a week, to review data, and signs reports. An Aramark employee was training to serve as a full time certified operator but was unable to pass the certification exam and is no longer an employee of Aramark. Aramark kept us apprised of this situation and they hired a tutor to help them achieve the directives of the compliance order. At this writing they have hired a full time certified operator with a current license in Indiana.

**HOOSIER STAMPING & MFG. CORP is a Metal Finishing Point Source Industry as defined by 40 CFR 433.15(a). This categorical definition applies to facilities performing operations in which metal is coated as in phosphating on any basis material and to related metal finishing operations set forth in the various subparts of the Metal Finishing section. Specifically this industry conducts iron phosphating.

Hoosier Stamping under the Categorical Standard has a monthly average limit of 1.48 mg/l for Zinc. The IU sample taken November 17, 2015 received a result of 1.8 mg/l. This was below the daily limit of 2.61 mg/l, however because no other samples were taken in November this condition resulted in a monthly average violation. Their permit also only required a sampling frequency of "Semiannual" during SNC analysis period (October 1, 2015 through March 31, 2016). During this period there were eleven (11) samples taken. None of these samples violated the daily limit of 2.61mg/l. In fact the average of all eleven samples is .645 mg/l, which is well below the monthly limit. So because only one sample was taken for the month of November and all ten (10) of the other samples were taken in January, only two (2) monthly average results were generated for the six (6) month SNC measurement period. This resulted in fifty (50) percent of the monthly average results exceeding the monthly average limit and therefore this condition met the SNC definition. An Administrative Order was issued by the Utility Board on June 7, 2016. The AO sought \$250.00 in fines, additional IU resampling. We have modified their Permit to increase the sample frequency. A \$250.00 check was received from Hoosier Stamping on June 23, 2016.

^{* &}lt;u>Authority sampling (1-8 days)</u> is a measure of a 24-hour composite sampler normally being set for a two week period, but only active Monday AM through Friday AM. Factors that can affect a week's sampling can be Holidays, weather conditions, staffing absences, lack of industrial flow, and equipment failure and batch discharges. These factors can reduce the scheduled four (4) samples normally acquired in a week. So if a: "2" is reported, it is likely that 16 samples were taken during the year when not influenced by adverse factors.

3) Summary of Compliance & Enforcement Activities

Inspection, Monitoring, Enforcement (Summary) 2016

1. ** Tin Man Brewing (IWP 002) is a non-categorical industry. In 2016, seventy-two (72) samples were taken on the waste stream of this industry. Fourteen, "Notice of Violations" were written during the year. Of the seventy–two samples; there were twenty (20) BOD violations and four (4) pH violations. This means that 28% of the BOD results were in violation in 2016.

The waste strength of Tin Man has substantial variation from day to day. For this reason they have a high sample frequency in their permit. We also obtain a more precise BOD monthly average concentration value that is used in calculating surcharges.

Previously USEPA approved our SUO that contained a 3694 mg/l BOD "daily max limit". This Ordinance approval was based on a study that recommended the use of the 3694 mg/l limit as a "monthly average limit." This same study also recommended a 6592mg/l, "weekly average limit" for the waste treatment facility that Tin Man discharges. Presently the Evansville Water & Sewer Utility is awaiting approval from USEPA of our request to incorporate the study's recommended "monthly average value" of 3694mg/l. If the monthly average value were used instead of the Daily Maximum value in measuring compliance, then most, if not all of the 20 violations would disappear.

The calculations used in this study have safety factors included to protect the POTW from pass through and interference. For these reasons Evansville Water and sewer has not pursued additional enforcement activities with Tin Man Brewing.

4) Changes to the POTW's Program not previously reported to the Approval Authority

The following are changes to Evansville Water & Sewer Utility's Pretreatment Program / Sewer Use Ordinance that have not been previously reported in our Quarterly reports.

Ordinance—G2016-12 was passed by common council on March 28, 2016. This ordinance amends Subsection 13.05.090 of Municipal Code. Language was removed or added to clarify requirements for installing and maintaining adequate grease interceptors. These changes enhance the POTW's ability to control Fats Oil and Grease discharged by any customer. A copy of the Ordinance can be found in Section 5 of this report.

- There were no changes to local pollutant limits, however a request for approval was made to USEPA in March 2016 to allow us to use "Monthly Average Limits" for BOD and TSS as recommended in the most recent Local Limits evaluation. The recommended values for the "Monthly Average Limits" were 3694 mg/l and 2114 mg/l respectively. The Ordinance and subsequent code transcription used 3694 mg/l and 2114 mg/l as a "Daily Maximum Limit" instead of the Monthly Average Limit. At this writing we are still awaiting approval from USEPA on this issue.
- There were no changes to ERP.
- There were no changes in personnel.

LEGAL AUTHORITY

The following findings are made and notice issued pursuant to the authority vested in the Pretreatment Program, under Chapter 13.20 of Title 13. of the Evansville Municipal Code. This order is based on the findings of violation of the conditions of the wastewater discharge permit issued under Chapter 13.05. & 13.20 of the City of Evansville's Sewer Ordinance and 40CFR Part 403.8(f) (2) (viii)

FINDINGS

1. <u>HOOSIER STAMPING</u> discharges nondomestic wastewater containing pollutants into the sanitary sewer system of the City of Evansville (hereafter, "City").

- 2. <u>HOOSIER STAMPING</u> is an "industrial user" as defined by Section 13.20.10 of the City's Waste Water Discharge Regulations.
- 3. <u>HOOSIER STAMPING</u> was issued a wastewater discharge permit on January 1, 2015. This permit contains prohibitions, restrictions, and other limitations on the quality of the wastewater it discharges to the sanitary sewer.
- 4. Pursuant to the ordinance and the above-referenced permit, data is routinely collected or submitted on the compliance status of **HOOSIER STAMPING**.
- 5. Data shows that **HOOSIER STAMPING** has violated the City Ordinance and their Industrial Wastewater Discharge **Permit (IWP010)** as further described below.
 - 1. You exceeded the monthly average for Zinc during November 2015. You reported a value of 1.80 mg/L. The monthly average is 1.48mg/L.

These violations meet the definition of "Significant Noncompliance" as defined in 40CFR Part 403.8 (f) (2) (viii) and Chapter 13 of City Code.

ORDER

THEREFORE BASED ON THE ABOVE FINDINGS, HOOSIER STAMPING IS HEREBY ORDERED TO:

- 1. Within ten (10) days, pay to the cashiers office of Evansville Water & Sewer Utility a fine of \$250.00 for each Violation or a total of \$250.00
- 2. Within ten (10) days coordinate with the Pretreatment Coordinator, an action plan detailing corrective action to prevent further violations. (The EWSU will require more sampling; thus modifying IWP010. This has been discussed with Hoosier Stamping personnel.)

This Order does not constitute a waiver of the discharge permit which remains in full force and effect. The city of Evansville Indiana reserves the right to seek any and all remedies to it under Section 13 of the Sewer Use Ordinance for any violation cited by this Order.

This Order, entered this 7th day of June 2016 shall be effective upon receipt by HOOSIER STAMPING.

AN ORDINANCE AMENDING CHAPTER 13.05 (SEWERS) OF THE EVANSVILLE MUNICIPAL CODE

WHEREAS, the Evansville Water and Sewer Utility Department follows best practices set by the Indiana Administrative Code and the Uniform Plumbing Code ("Standards"); and

WHEREAS, as a result of changes and additions to the Standards, the Evansville Water and Sewer Utility recommends that Chapter 13.05 of the Evansville Municipal Code be amended; and

WHEREAS, the City Council of the City of Evansville ("City Council") wishes to adopt such recommendations by amending Chapter 13.05 of the Evansville Municipal Code.

NOW, THEREFORE, BE IT HEREBY ORDAINED by the City Council of the City of Evansville, Indiana that Chapter 13.05 of the Evansville Municipal Code is hereby amended as follows:


SECTION 1. AMENDMENT OF SUBSECTION 13.05.090 OF THE EVANSVILLE MUNICIPAL CODE.

Subsection 13.05.090 shall be amended by eliminating words or clauses that are stricken (red) in the following statement of Subsection 13.05.090 and adding the words or clauses that are underlined (blue) in the following statement of said Subsection:

13.05.090 Grease, oil or sand traps.

- (A) Any building sewer which will have or has the potential to discharge waste containing grease, oil, sand or similar substances shall have a grease, oil and/or sand trap ("Grease Trap") installed. Disposal to the sewers of mineral-based oils and greases is expressly prohibited. Grease †Traps shall not be required for private living quarters or dwelling units, but are mandatory for all restaurants and/or food preparation services. In no case shall a Grease Ttrap of less than 50 pounds grease retention capacity be installed. Grease Traps shall be installed and maintained in such a manner as to provide at all times the effective removal of these substances before discharge to the public sewer. All Grease †Traps shall be of the standard type and capacity which meets City and State requirements and shall be readily and easily accessible for cleaning and inspections. Additives which emulsify or impede the separation of oils and grease shall not be allowed. Where required under this section, the cost of and responsibility for installation and maintenance of the traps shall be the sole responsibility of the utility user.
- (B) Any structure having a grease trap meeting the requirements of City and State codes prior to the effective date of the ordinance codified in this section may





remain and constitute compliance as long as the old. A Grease Trap must be installed that trap-is of sufficient capacity and design to prevent grease, oil or sand from entering the public sewer. If the old-a previously installed Grease Ttrap is replaced or cannot prevent said materials from entering the sewer system, then the replacement Grease Ttrap shall meet the requirements of subsection (A) of this subsection. [Ord. G-96-10, passed 7-22-96; Ord. G-90-12, passed 6-12-90; Ord. G-81-3, passed 1-25-82. 1982 Code § 50.17; 1983 Code § 5.50.17.]

(C) Grease interceptor cleaning and maintenance shall include pumping the interceptor until empty, and cleaning the side walls, baffle walls and cross-pipes, and inlet and outlet pipes. Decanting, skimming, or back flushing is prohibited. A full pump-out is required. In the event that the Grease Trap volume is greater than the tank capacity on the vacuum truck, the transporter shall arrange for additional transportation capacity so that the trap is fully evacuated within a 24-hour period.

SECTION 2. EFFECTIVE DATE

This Ordinance shall be in full force and effect after its passage by the City Council and signing by the Mayor.
