<u>Commercial Real Estate Signs</u> <u>On - Premises</u> <sup>2</sup>	2	50 sq. ft.	Removed within 14 days of the sale, rental, or lease of the property
<u>Off - Premises Directional</u> <sup>2,3</sup>	2	4 sq. ft.	3 days before and 6 hours after open house
<u>Auction Signs</u> <u>On - Premises</u> <sup>2</sup>	2	16 sq. ft.	Removed within 14 days of the auction
<u>Off - Premises Directional</u> <sup>2,3</sup>	2	9 sq. ft.	3 days before and 6 hours after the auction
<u>Banners</u> <u>General</u> <sup>2,4</sup>	1	32 sq. ft.	Unlimited
<u>Award</u> <sup>2</sup>	1	18 sq. ft.	Removed after the year the award was given
<u>Feather</u> <sup>2</sup>	1	Unlimited	Cannot exceed 30 consecutive days in 1 year period
<u>Pennants/ Inflatables</u> <sup>2,5</sup>	Unlimited	Unlimited	Cannot exceed 30 consecutive days in 1 year period
<u>Garage Sale Signs</u> <sup>2,3</sup>	1	4 sq. ft.	1 week prior to and 6 hours after the sale
<u>Construction Signs</u> <u>Single Family/ Duplex</u> <sup>2</sup>	2	9 sq. ft.	Unlimited - But must be removed upon issuance of a certificate of occupancy for the building
<u>Multi-Family/Non-Residential Use</u> <sup>2</sup>	2	50 sq. ft.	
<u>Sponsorship Signs</u> <sup>2,5</sup>	Unlimited	Unlimited	Unlimited
<u>Special Event Signs</u> <u>On - Premises</u> <sup>2,5</sup>	Unlimited	32 sq. ft.	30 days prior to and 7 days following the event
<u>Off - Premises</u> <sup>2</sup>	1	6 sq. ft.	

Footnotes
<p>1. Signs that meet the description and criteria per zoning code - do not require a sign permit, are exempt from all sign permit application requirements, are not taken into account when calculating the total number of signs or the total square footage of signs allowed for a property or business, and are not limited in number (with the exception of Sandwich Board and Window signs) nor in the length of time they may be maintained.</p> <p>2. Signs that meet the descriptions and requirements per zoning code – do not require a sign permit and are not taken into account when calculating the total number of signs or the total square footage of signs allowed for a property or business. Signs that meet the descriptions but that do not comply with the requirements for exemption will be allowed only with a sign permit, and are subject to all requirements and limitations for sign permits as to the property or business.</p> <p>3. Additionally, to the total number of signs, 1 Off-Premises "Lead In" sign is permitted.</p> <p>4. May not be used as a permanent sign except for on-premise within first six months of the opening of a new business.</p> <p>5. Although the number of signs and/ or the size of the signs allowed may be labeled "Unlimited", the maximum area allowance for each zoning district is still an active restriction.</p>

<p>1. May pick from one (1) type of sign category for exemption only.</p> <p>2. No exemptions are allowed when used in conjunction with an electronic message board.</p>
