This addendum forms a part of the Bidding and Contract Documents and modifies the original bidding documents dated May 29, 2025. The Bidder shall acknowledge receipt of this addendum on the Proposal Form. Failure to do so may result in the disqualification of the Bidder.

GENERAL INFORMATION

Item 1: Pre-Bid Meeting:

The Mandatory Pre-Bid Meeting was held at Station 15 on June 9, 2025, at 1:00 pm. The attendance sheet is attached.

Architect Mike Ewald gave a brief overview of the project and a tour of the work areas. Contractors were allowed to spend time on site if they wished. Topics discussed:

- 1. Contractors may visit the site by contacting EFD Facilities Mgr. Dustin Cline to schedule. Mr. Cline's contact information is on the attendance sheet.
- 2. Emphasized the importance of the facility remaining in service to make emergency runs 24 hours per day.
- 3. Pointed out the obvious lack of free space on the site for construction equipment, vehicles, etc. EFD will work with contractors to free up as much space as possible. The EPD Guardian surveillance trailer will not be on the site during the project.
- 4. Isolate work and utility disruptions to the areas affected. Any utility disruptions need to be coordinated with the EFD Facilities Manager ahead of time.
- 5. EFD crews, unless communicated otherwise, will operate 24 hours/day out of Station 15.
- 6. EFD will make the spare apparatus bay space available for contractor staging and work area.

7. Mike Ewald referenced similar work done at EFD Station 6 and offered to share some photos of that work.

Item 2: Clarification – Project Schedule:

The Evansville Fire Department wishes to have the project commence as soon as possible following the receipt of bids, bids taken under advisement, and a bid award at a Board of Public Safety meeting in July. Assume executed contracts and notice to proceed by August 29, 2025.

<u>Contractors shall insert on the Bid Form the number of calendar days required for their</u> <u>firm to complete the entire project.</u>

Item 3: Information – Lighting Fixtures: Cooper Lighting is an approved manufacturer.
