

1. Introduction

The Americans with Disabilities Act (ADA) of 1990 is a civil rights statute that prohibits discrimination against people who have disabilities. There are five separate Titles (sections) of the ADA relating to various aspects of potential discrimination. Title II of the ADA specifically addresses the subject of making public services and public transportation accessible to those with disabilities. Under the terms of the ADA, designing and constructing facilities for public use that are not accessible by people with disabilities constitutes discrimination.

Accessibility plays a significant role in the inclusion of people with disabilities. The first step toward fulfilling the rights of people with disabilities is creating an accessible, barrier-free environment. Regulations require that barriers that are structural must be removed in public areas of existing facilities when such removal is readily achievable. Typical barriers can include things such as routes of travel requiring the use of stairs, non-ADA compliant ramps, door widths that cannot accommodate the passage of a wheelchair, and the location of door handles that are too high.

Discrimination against individuals with disabilities occurs when a person is perceived differently, treated differently, and struggles to gain acceptance at a level experienced by their non-disabled peers. Physical barriers encountered by people with disabilities can often be perceived as discrimination because they exclude that individual from reaching their desired destination or performing a specific task or action. According to the ADA, all State and local governments are required to follow specific architectural standards in either the new construction or in the alteration of existing buildings unless the corrective actions would result in undue financial or administrative burdens. To avoid discriminating against those with disabilities, public entities are required to make reasonable modifications. These modifications can provide equality of opportunity, but the county cannot guarantee equality of results.

Title II requires local governmental agencies to ensure that all of their programs, services, and activities, when viewed in their entirety, are accessible to people with disabilities. Program access is intended to remove physical barriers to the local governmental agency services, programs and activities, but it generally does not require that the local governmental agency make *each* facility, or *each part* of any given facility, accessible. For example, every restroom in a given facility does not need to be made accessible. However, signage directing individuals with disabilities to the accessible features and spaces within that given facility must be provided.

Program accessibility may be achieved through a variety of ways. Local governmental agencies may choose to make structural changes or pursue alternatives to structural changes to achieve access. For example, the local governmental agency can move public meetings to accessible buildings and relocate services for individuals with disabilities to accessible levels or parts of a building. It should be noted that when choosing between possible methods of program accessibility, the local governmental agency must give priority to the choices that offer services, programs, and activities in the most integrated setting that is available and appropriate. Additionally, all newly constructed public facilities must be fully accessible to people with disabilities.

The most efficient way for communities to ensure Title II's requirements are being met is through self-evaluation. Self-evaluation enables local governments to pinpoint the facilities, programs, and other services that must be modified or relocated in order for that local government agency to comply with the ADA. Once a comprehensive self-evaluation has been completed, local government agencies are then required to develop a Transition Plan to address any and all deficiencies. The Transition Plan is intended to achieve the following:

- Identify physical obstacles that limit the accessibility of facilities to individuals with disabilities.
- Describe the methods to be used to make the facilities accessible.
- Provide a schedule or program for making access modifications.

ADA Transition Plans are required from all local governmental agencies to cover all facilities under their control. In order to meet these requirements, Vanderburgh County, through its Commissioners as the officials responsible for implementation of ADA Transition Plans, completed a Transition Plan in 2015. That plan evaluated publicly managed pedestrian facilities located within the county owned rights-of-way. This included sidewalks, curb ramps, street crosswalks, driveway crossings, and median crossings. The 2015 plan also provided an assessment of County offices and County buildings. This report is an update of that 2015 Transition Plan.

Sidewalk and Curb Ramp Updates

The 2015 Transition Plan provided the following list of infrastructure projects that may include the construction of compliant curb ramps:

- Roadway and sidewalk construction and/or retrofit projects planned for the improvement of overall vehicular and pedestrian facilities. These projects would include Road Rehabilitation projects, Transportation Enhancement projects, Safe Routes to School project and other such surface transportation improvement initiatives.
- Curb ramp, sidewalk and intersection crosswalk retrofit projects included with road overlay or other street and/or sidewalk construction projects. Where applicable, all street and sidewalk maintenance and rehabilitation activities and projects should be programmed and developed to implement barrier removal.
- 3. Curb ramp, sidewalk and intersection crosswalk retrofit activities done in conjunction with private land development projects. If public pedestrian facilities are affected during the construction of such projects, the replacement facilities should be done in accordance with the Codes and Standards listed herein.
- 4. Curb ramp, sidewalk and intersection crosswalk retrofit activities done in conjunction with drainage or utility projects. Where applicable, any disturbance to the existing public pedestrian facilities by public or private utility companies should be restored in accordance with the Codes and Standards listed herein.

Vanderburgh County has been including new curb ramps in these project types in order to reduce the number of non-compliant ramps throughout the county. Since the 2015 Plan was prepared, Vanderburgh County has included new curb ramps in all road reconstruction projects where sidewalks either existed or were being added as a part of the project. In addition, as road repair and resurfacing projects have been done, the County has included the construction of curb ramps that are compliant with current standards in these paving contracts. This process will continue to be followed as road work is done in areas with non-compliant ramps.

For private developments, Vanderburgh County ordinances require sidewalks to be inspected for ADA compliance before certificates of occupancy are issued for new homes in subdivisions where sidewalks are required. This ensures that the new sidewalks and curb ramps are properly constructed as they are built. This process will continue to be followed for all new sidewalks constructed in subdivisions.

Since the 2015 Transition Plan was prepared, 161 non-compliant ramps have been replaced with new curb ramps. These have been completed when road repair contracts have been done. The total cost of these ramp replacements was \$414,620.00. In addition, 92 new ramps have been constructed as a part of road reconstruction projects where sidewalks were added where none previously existed. The total cost of the new ramps in those locations was \$285,456.00.

The updated 2025 inventory data is as follows:

- 111.09 miles of sidewalks exist throughout outside of city limits in Vanderburgh County.
- 656 compliant curb ramps
- 370 non-compliant curb ramps
- 121 locations that have no curb ramps at all and may need to have curb ramps.

See Appendices A through D for lists of the curb ramp inventory data listed above.

Vanderburgh County, through annual road repair contracts entered into by the Vanderburgh County Commissioners, will continue to replace non-compliant ramps in conjunction with road repair and resurfacing contracts. The County will also continue to add compliant curb ramps in all road reconstruction projects that involve the construction of new pedestrian facilities. The estimated cost of providing these ramps is \$2,500 to \$5,000 each, depending upon the type of ramp and its location.

Vanderburgh County Building Assessment Updates

As was stated in the 2015 Transition Plan, Vanderburgh County has a relatively large number of facilities, so it is not possible to immediately remove all known barriers to access. The barriers identified in the 2015 plan will continue to be removed systematically in an attempt to ensure equality among all programs. It is the intent of Vanderburgh County to address barriers to accessibility in its public facilities within a reasonable time frame, depending on the immediate necessity, degree of complexity, overall cost, and availability of funding.

The 2015 Transition Plan provided the following recommended priority schedule as guidance to assist in developing the schedule of improvements:

Priority One: The highest priority should be placed on those barrier removal items that provide accessibility at the main entrance of a facility or improve a path of travel to the portion of the facility where program activities take place.

Priority Two: A second level priority should be placed on those barrier removal items that improve or enhance access to program use areas.

Priority Three: A third level priority should be placed on those barrier removal items that improve access to amenities serving program areas.

Priority Four: A fourth and lowest level of priority is used to identify areas or features not required to be modified for accessibility because there are no public programs located in this space, or because there are similar features located nearby that reasonably provide programmatic access.

While these recommended strategies have been used whenever possible, Vanderburgh County reserves the right to modify these barrier removal priorities as needed. These priorities may be modified to allow for flexibility in accommodating community requests, to address petitions for reasonable modifications from individuals with disabilities, and to accommodate changes in County programs. The priorities may also be revised due to funding constraints and/or new funding opportunities.

The implementation of barrier removal has typically been funded in two different ways. First, for smaller, less expensive items (such as restroom grab bars, braille signage, and door hardware), the costs of the barrier removal have been included in various budget line items for County offices. Major projects (such as new buildings, major building renovations, road reconstruction projects, etc.) that require specific allocation of funds by the County Council and County Commissioners are undertaken and completed as funding allows. These two funding strategies have allowed Vanderburgh County to address many of the barriers that were identified in the 2015 Transition Plan.

Updated assessments of Vanderburgh County offices and buildings that were listed in the 2015 Transition Plan are provided in the following pages. Any updates and corrections that have been completed since the 2015 assessments are listed below the 2015 data.

The Old Courthouse

The 2015 report identified the following issues:

- A disabled parking space exists in the parking lot on Vine Street, but no access aisle is provided. The parking space needs to be painted to provide a proper access aisle.
- Exterior and interior signs need improvement. Directional signage to major public areas, elevators, and restrooms should meet ADA standards. Exterior signs are needed to indicate the location of the nearest accessible entrance.
- The historic interior door hardware is not compliant.
- Many door thresholds in the building are higher than ¼" or ¾" sloped. These could be replaced by standard thresholds to comply.

2025 Update:

The Vine Street parking lot was re-striped in 2023 to provide an access aisle, but the striping has faded, and the lot needs to be re-striped again. ADA signs also need to be provided for the parking spaces. The changes are anticipated to be completed in 2026.

Interior signs were updated to provide directional signage to major public areas, elevators, and restrooms. Additional sign revisions are needed in order to meet ADA standards. Additional exterior signs that meet ADA standards are still required.

No updates have been made on interior door hardware or door thresholds.

The Old Courthouse is listed in the National Register of Historic Places, so alterations are not required if they could destroy or threaten the historical significance of this historic property. Vanderburgh County and the Old Courthouse Foundation will continue to evaluate what alterations can be implemented to improve accessibility without affecting the historical significance of the Old Courthouse. This will be an ongoing process, and issues will be resolved as funding is available, with an ideal timetable for completion by the end of 2028.

Health Department

The 2015 report identified the following issues:

• Disabled parking spaces have been identified but none of them meet the Van Accessible requirements. The parking lot would be complaint by repainting a proper Van Accessible access aisle (See Image E) and providing a standard ADA Sign on a post.

2025 Update:

The parking spaces have been re-striped, but van accessible spaces were not provided, and standard signs were not installed. Since this office is leased, the County will notify the landlord to request that the ADA parking spaces need to be revised to comply with all applicable ADA requirements. The director of the Health Department will notify the landlord of this issue in 2026 and will encourage the landlord to make the necessary changes as promptly as possible.

Highway Department

• A disabled parking space has been identified but no access aisle is provided. The parking space would be complaint by painting a proper access aisle (See Image F).

- The main entrance to the building is 2.5" higher than the adjacent sidewalk (See Image G). Sidewalk should be reworked to provide proper accessible route.
- The reception counter in the main office is higher than 36 inches high and not 36 inches long. A portion of the counter could be lowered to meet the requirement.

2025 Update:

The disabled parking space in front of the building needs to be repainted. All prior striping has faded, and no access aisle exists. Applicable ADA signs must also be posted.

The sidewalk at the main entrance has not been altered, so the 2.5" elevation difference at the door still exists. The sidewalk must be reconstructed to provide an accessible route.

The reception counter still requires modifications in order to meet applicable ADA requirements. These issues are expected to be addressed beginning in 2026.

Weights and Measures

The 2015 report identified the following issues:

- The parking area for the building is a gravel lot with no designated accessible spaces. The lot needs to be paved, painted, and have proper signage installed to be compliant.
- There is very little signage on the outside of the building directing a visitor where to go. ADA compliant signage, including braille, should be provided.
- The entrance thresholds to the building are higher than ¼" or ¾" sloped. This could be replaced by a standard threshold to comply.

2025 Update:

The Weights and Measures department leases this office space, and the building owner has not provided a timetable for making any revisions to this site. The director of the Weights and Measures department will notify the landlord about these issues in 2026, and the director will request a timetable for addressing the issues with encouragement for these issues to be resolved as promptly as possible.

Coroner's Office

The 2015 plan identified the following issues:

- A disabled parking space has been identified but the access aisle is not at least 60" wide. The parking space would be complaint by painting a proper access aisle and raising the sign to above 60" (See Image J). Also, there is no Van Accessible space provided.
- The reception counter in the main office is higher than 36 inches high and there is not clear floor space of 17 25" under the counter. The countertop could be lowered and deepened to meet the requirement (See Image K).
- The Accessible toilet room needs some minor accessory improvements to be compliant. See Priority 3 Data in Appendix for details.

2025 Update:

A new coroner's office is currently under construction and is expected to be completed in October 2026. The new office will meet all applicable ADA design standards, so deficiencies of the existing building as

listed in the 2015 report will not be corrected. The new office construction is being completed by the Evansville – Vanderburgh County Building Authority.

Soldiers and Sailors Memorial Coliseum

The 2015 report identified the following issues with the Coliseum:

- There are accessible parking spaces available around the building, but the markings are not very clear. The spaces need repainting, and signs need to be raised above 60".
- The facility currently uses the loading dock as the accessible access. From a technical perspective,
 the loading dock slope is too steep, there are no handrails, and the thresholds along this route are
 too high. Also, requiring a disabled person to use a loading dock to access the building raises some
 dignity issues that do not comply with the intent of the ADA. The building needs a proper ADA ramp
 in a different location to be complaint.
- The Women's restroom is much closer to full compliance than the Men's restroom. The Women's restroom needs some minor accessory improvements to be compliant. The Men's has some ADA accessories but the toilet compartment is too small and access is restricted, including a step near the urinal area, presumably a plumbing chase.
- The drinking fountain is too high to comply with ADA requirements.

2025 Update:

The Coliseum is currently closed, so there are no public events being held in this building, and there are no public offices in this building. The Vanderburgh County Commissioners are responsible for this building, and they had a study completed in 2022 to determine what improvements were needed throughout the building. That report stated that ADA seating improvements were required, and that the restrooms needed to be upgraded to comply with ADA. While the County has long-term plans to complete the major renovations recommended in the study, there is no current timetable for these renovations due to the lack of available funding. A timeline for the renovations will be determined at a later date as funding is identified. ADA deficiencies will be addressed as the renovations are completed. These issues will be addressed and planned for if the Coliseum is reopened to the public.

West Heights Trade School

The 2015 Plan stated the following regarding the training building located in the rear of the lot:

- The parking area does not have designated accessible spaces. The lot needs to be painted and have proper signage installed to be compliant.
- There is very little signage inside or outside of the building directing a visitor where to go. ADA compliant signage, including braille, should be provided.
- A temporary ramp is provided at entrance when needed, but not compliant (See Image Q). Minor rework of the concrete in this area could make the entrance accessible.
- The Accessible toilet room needs some minor accessory improvements to be compliant. See Priority 3 Data in Appendix for details.

2025 Update:

Since this building is not open to the general public, and due to inadequate funding, the deficiencies noted in the 2015 report have not been corrected. This building is currently used only for training for state and local police, and as a backup emergency operations center. Due to the limited use of this facility, a new assessment needs to be completed to determine the types of improvements needed to serve the current

users of this site. A new assessment of the building is expected to be completed in 2026, and then recommended improvements are anticipated to be completed in 2027 and 2028.

Burdette Park

The 2015 report identified the following deficiencies:

- Most drinking fountains throughout the park do not comply with ADA requirements.
- Accessible parking spaces are not provided or properly indicated at most park destinations.
- Adequate fire alarm systems that provide audible and visual alarms are not consistently provided in facilities.
- Flooring in many facilities is not slip resistant could use refinishing or secured mats.

Areas for improvement per building:

Office

- Counter height is too high for compliance
- Directional signage needs improvement
- Toilet rooms are not accessible

Discovery Lodge

- Parking needs ADA sign on post and van accessible space(s)
- Toilet rooms need minor accessory adjustments

Pavilion / Storm Shelter

- Currently no accessible parking reconfigure / repaint spaces
- Pavilion ramp is not accessible from main office
- Main entrance is through office building; secondary entrance is through a normally locked, unmarked gate with noncompliant slope
- Ramps need proper handrails
- Storm shelter toilet rooms need minor accessory adjustments
 - o Raise ADA Sign to proper height
- Counter height is too high and shallow for compliance
- Toilet room could use minor accessory improvements

Bishea Building

- Parking is compliant, but needs ADA sign on post
- Ramp is slightly too steep and requires handrail
- Exterior directional signage is needed
- Accessible entrance door threshold is too high
- Toilet rooms need proper signage and minor adjustments

Clubhouse

- Parking is shared with Shelter House #19 no immediate accessible parking
- Slope and cross slope of exterior accessible route is too steep
- Proper directional signage is needed both on exterior and interior
- Door hardware needs improvement. See Appendix data.

- Interior space on lower level needs reconfiguration.
- Lower level is accessible from exterior only via steep slope (no elevator or lift)
- Toilet room needs significant improvement not enough space is provided

Lakeside

- Parking is located across the street and lacks an immediate accessible parking space
- Door threshold needs rework
- Interior signage needs improvement (indicate accessible entrance to lower level from exterior)

Chalet

- Second level is only accessible via stairs
- Parking is not marked repaint and incorporate proper signage to make compliant

First Aid

*Parking indicated is also the accessible lot for the aquatic center

- Parking needs reconfiguration, proper signage to be van accessible and located closest to accessible entrance
- Accessible route needs regarding
- Exterior directional signage needs improvement

Miniature Golf

- Parking needs reconfiguration to be marked as accessible
- Service counter is too high

Aquatic Center

*See First Aid for accessible parking

- Accessible route slope needs regarding
- Accessible interior route threshold issues need improvement
- Exterior signage needs improvement
- Accessible seating should be provided at dining facility; service counter needs reconfiguration
- Toilet rooms need toilet stall and accessory improvement

Shelter House #13

- Parking requires proper signage
- Door hardware, threshold need improvement
- Toilet rooms need minor improvement

Shelter House #18

- Parking needs proper signage
- Entrance ramp needs reconfiguration
- Door hardware, threshold could use improvement
- Interior signage needs improvement
- Toilet rooms need minor improvement

Shelter House #19

- Parking needs proper signage
- Slope, cross slope are questionable

• Interior signage at toilet rooms needs improvement

Shelter House General Comments

- Some Shelter Houses are indicated by Burdette as noncompliant or "functional," meaning they can be used by persons with disabilities if accompanied by a non-disabled person
- The Shelter Houses with full reports are the accessible facilities, others have inaccessible entrances or noncompliant exterior access routes

Campground Shower Rooms

- Exterior signage needs improvement
- Showers are not accessible require step up
- Toilet rooms need minor accessory improvements

2025 Update:

The Vanderburgh County Commissioners are responsible for Burdette Park and adopted an updated master plan in June 2025. Each of the below issues will be addressed as funding allows with an intention to address the issues by the end of 2030. The master plan provided the following assessments of various park facilities:

Playground Equipment

The master plan states the following: "Although not technically required by the ADA, the addition of inclusive playground equipment is important for the enjoyment of all potential visitors." The installation of inclusive playground equipment can be evaluated in conjunction with future improvements to various sections of Burdette Park.

Water Fountains

The master plan states the following: "A long-term goal for the Park can be to replace water fountains and spigots with accessible water fountains." The 2015 ADA Transition Plan also stated that most drinking fountains throughout the park do not comply with ADA requirements. Water fountains can be replaced as funding is available and if future improvements are made to any sections of the park.

Shelter House #13

The 2015 issues (parking requires proper signage; door hardware, threshold need improvement; toilet rooms need minor improvement) still exist. However, the 2025 master plan states that shelter house #13 is "... one of the more easily-accessed shelters in the Park."

Shelter House #18

The issues identified in 2015 still exist, and they will be corrected as funding is available. Despite the deficiencies, the 2025 master plan states that "The Shelter offers convenient access from parking spaces to both the building entrance and the outdoor seating area."

Shelter House #19

According to the master plan, shelter #19 "is accessible and features universal picnic tables for inclusive seating. It offers convenient access to the deck and is located adjacent to the

entrance, providing easy parking options." As indicated in the 2015 Plan, the parking needs proper signage and the interior signage at toilet rooms needs improvement.

Bishea Building

The master plan states that "the building features both stairs and a ramp, ensuring accessibility for all attendees. Additionally, it offers ample parking, including designated accessible parking spaces." The deficiencies noted in 2015 (parking is compliant, but needs ADA sign on post; ramp is slightly too steep and requires handrail; exterior directional signage is needed; accessible entrance door threshold is too high; toilet rooms need proper signage and minor adjustments) will be addressed as funding allows.

Shelters 12, 16, and 17

The 2025 master plan stated that these three shelters are not accessible due to issues such as excessive slopes and stairs. These are among the shelters that are considered by Burdette as noncompliant or "functional," meaning they can be used by persons with disabilities if accompanied by a non-disabled person. These shelters have not been upgraded since 2015, and there are currently no plans for any changes due to the lack of available funding.

Clubhouse

According to the 2015 Transition Plan, the clubhouse lacks accessible parking, the slope and cross slope of the accessible route are too steep, additional signs are needed, door hardware needs improvements, there is no elevator or lift for accessibility to the lower level, and the toilet rooms are inadequate. These are some of the reasons why the 2025 master plan considers this building as being inaccessible. No funding has been available since the 2015 Plan was prepared, so no changes have been made to any of the deficiencies noted in 2015. These issues may be addressed in the future if sufficient funding is available.

Chalets

The issues identified in 2015 still exist at the chalets. The master plan also notes similar issues, so no changes have been made at the chalets.

The recommendations from the 2025 master plan were utilized to develop the priority schedule for improvements within Burdette Park as shown on page 14. This schedule indicates the responsible parties for the various improvements listed in the table. While some of these recommendations do not specifically address ADA issues, implementation of the recommendations can incorporate accessibility improvements. These improvements could potentially address the areas listed in the 2025 master plan, as well as all other areas of the park that had accessibility issues as listed in the 2015 Transition Plan.

In addition to the previously listed areas of the park that were evaluated as a part of the master plan, there are also two areas that have been reconstructed since the 2015 Transition Plan was prepared: the tennis courts and the miniature golf course. The tennis courts have been replaced with pickleball courts. Accessible parking was provided at the pickleball courts as a part of the project. The miniature golf course has been removed and replaced with a playground. A ramp has been constructed to access the playground from the concession area. However, the playground does not have an ADA compliant surface.

Grievance Policy and Complaint Procedure

If a person (or group of people) believes he or she may have been the victim of discrimination based on his or her disability, that person (or group of people) may file a grievance against the county. To expedite this process, Vanderburgh County has adopted a policy that covers the process that the person (or group of people) should follow to file the grievance, as well as the process that the county must follow in evaluating and resolving the grievance. A copy of the policy and the official grievance form are included in this plan.

Vanderburgh County will keep copies of all grievances filed, along with all paperwork regarding the evaluation and resolution thereof for a minimum of six (6) years.

Vanderburgh County strives to maintain the rights of its citizens at every level of government. Therefore, the county's grievance policy and procedure were developed such that a grievant could complete the local grievance procedure and appeal, if needed, and still have the opportunity to file a grievance with a state or federal agency within the known allowable timeframes from the date of the alleged discrimination.

The grievance procedure and ADA complaint form are provided in Appendix E. The procedure and complaint form were reviewed as a part of this 2025 update, but no changes were needed.

APPENDIX E

GRIEVANCE PROCEDURE AND ADA COMPLAINT FORM

Vanderburgh County, Indiana Grievance Procedure under the Americans with Disabilities Act

This Grievance Procedure is established to meet the requirements of the Americans with Disabilities Act of 1990 ("ADA"). It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in the provision of services, activities, programs, or benefits by Vanderburgh County. The County Employee Handbook set forth in chapter 2.90 of the Vanderburgh County Code governs employment-related complaints of disability discrimination.

Any person who has a complaint regarding the County's alleged non-compliance with the ADA may file a complaint. The complaint should be submitted by the grievant and/or his/her designee as soon as possible, but no later than 60 calendar days after the alleged incident. The complaint should be in writing and it should contain information about the alleged incident including the name, address, phone number of complainant and location, date, a description of the problem, and your suggestions for resolving the problem.

All grievance complaints must be submitted on the attached form, and sent to the following address:

Alternative means of filing complaints, such as personal interviews or a tape recording of the complaint, will be made available for persons with disabilities upon request.

Upon receipt of a complaint, the President of the Vanderburgh County Commissioners shall forward the complaint to the Vanderburgh County ADA Coordinator. Within 30 calendar days after receipt of the complaint, the ADA Coordinator or his/her designee shall meet with the complainant to discuss the complaint and possible resolutions to the same. Within 30 calendar days of the meeting, the ADA Coordinator or his/her designee shall respond in writing, and where appropriate, in a format accessible to the complainant, such as large print, Braille, or audio tape. The response will explain the position of Vanderburgh County and offer options for substantive resolution of the complaint.

If the response by the ADA Coordinator or his/her designee does not satisfactorily resolve the issue, the complainant and/or his/her designee may appeal the decision within 30 calendar days after receipt of the response to the Board of Commissioners of Vanderburgh County.

Within 30 calendar days after receipt of the appeal one member of the Board of Commissioners of Vanderburgh County shall meet with the complainant to discuss the complaint and possible

resolutions. Within 30 calendar days after such meeting, the Board of Commissioners of Vanderburgh County will respond in writing, and, where appropriate, in a format accessible to the complainant, with a final resolution of the complaint.

All written complaints received, all appeals to the Board of Commissioners of Vanderburgh County, and all responses to the complaints and appeals will be retained by Vanderburgh County for at least three years.

The right of a person to a prompt and equitable resolution of the complaint filed hereunder shall not be impaired by the person's pursuit of other remedies such as the filing of an ADA complaint with the responsible federal department or agency. Use of this grievance procedure is not a prerequisite to the Complainant's pursuit of other available remedies available by law.
