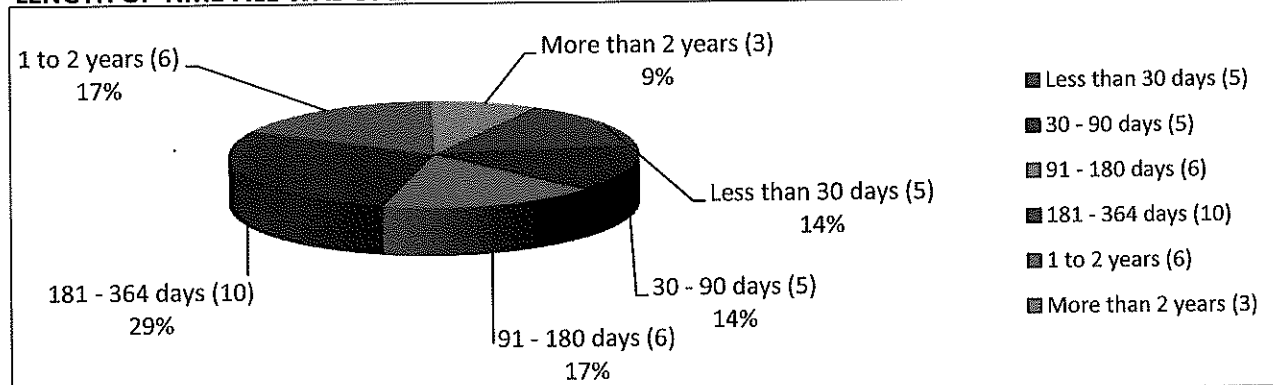
CLOSED CASES DISPOSITION

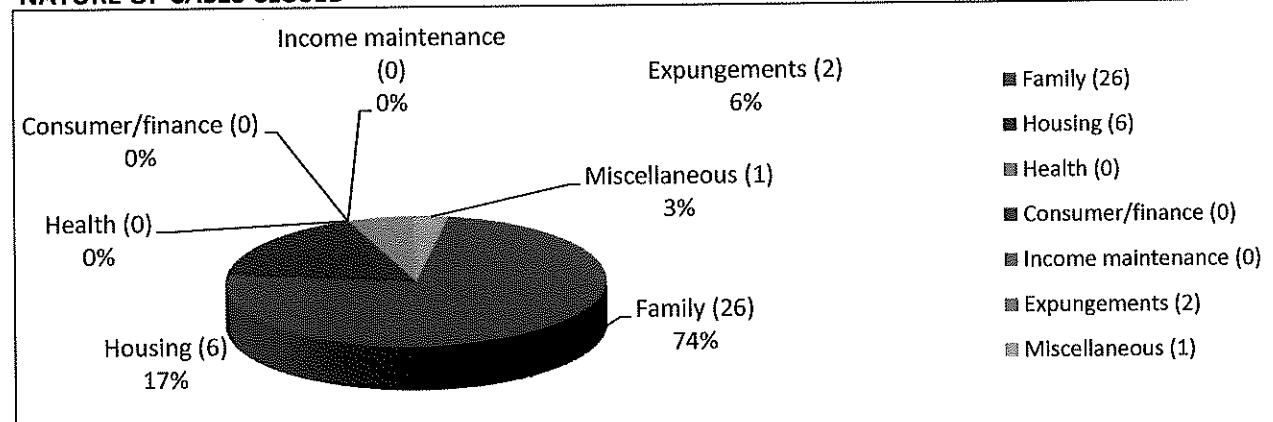

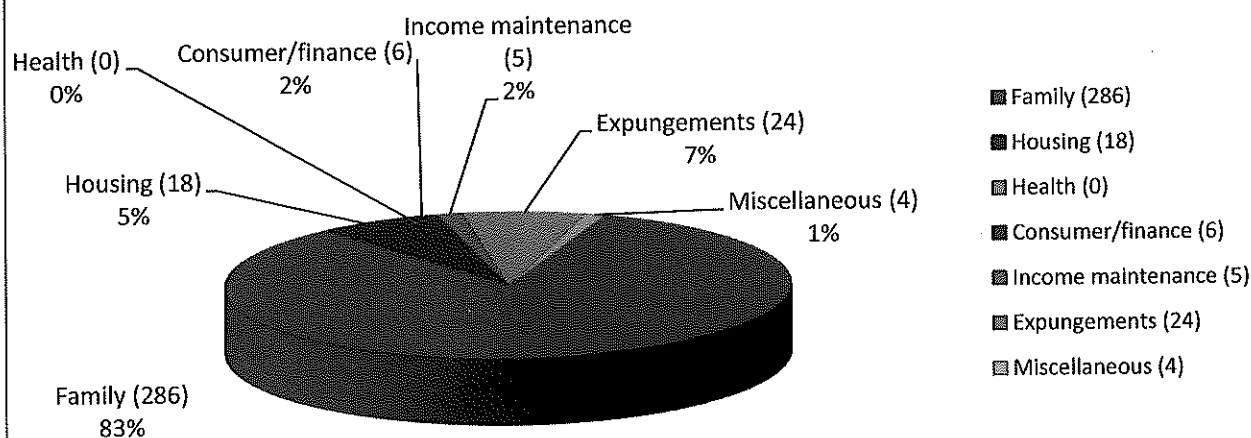

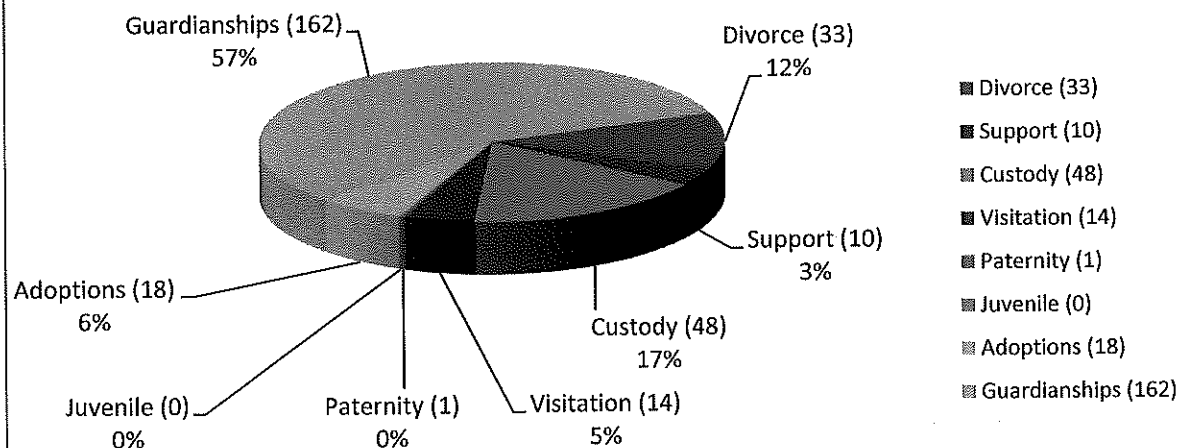
