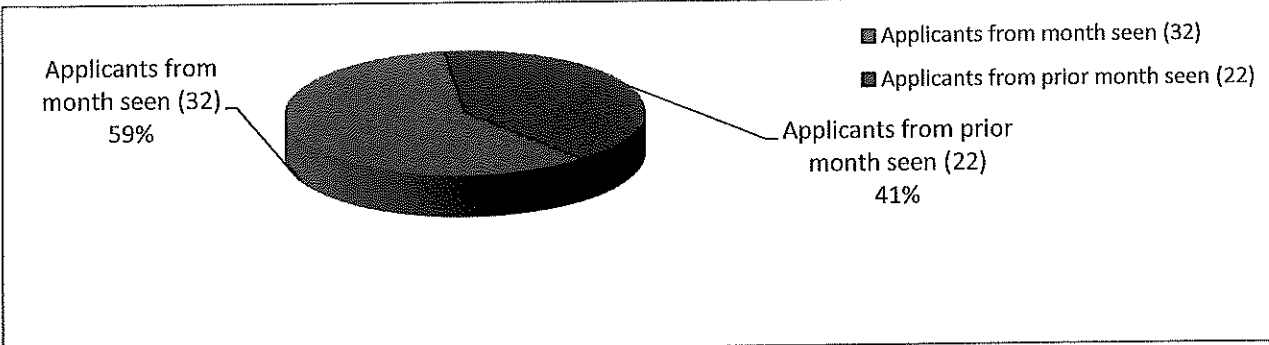

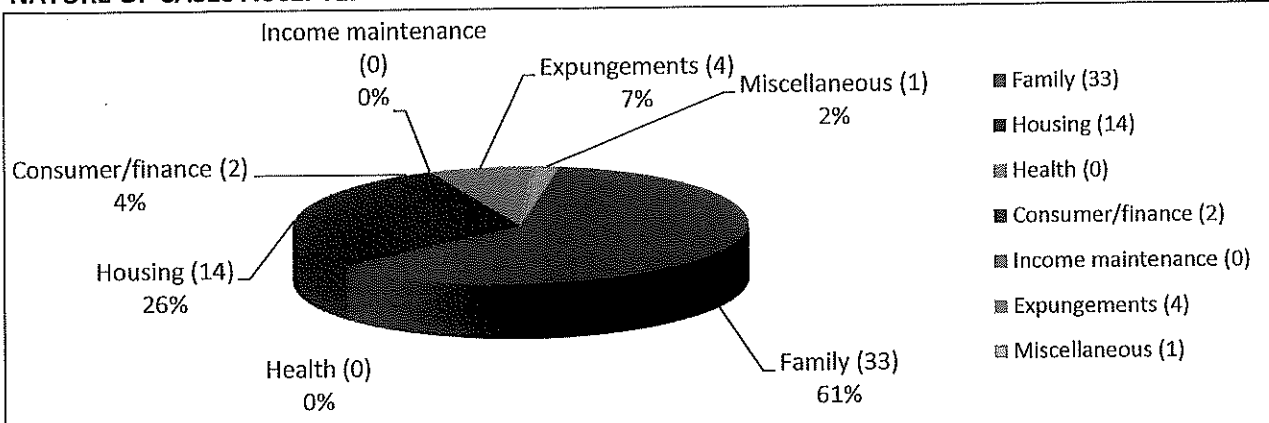

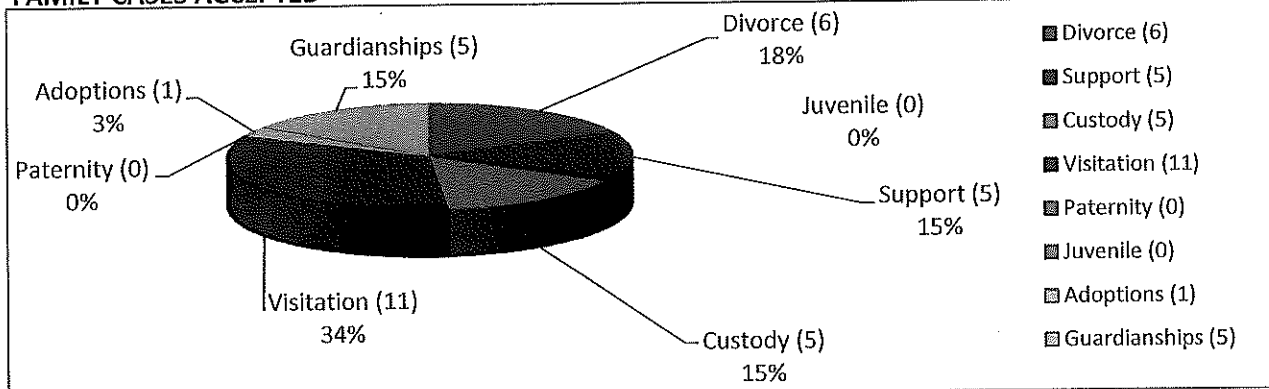
NATURE OF CASES ACCEPTED

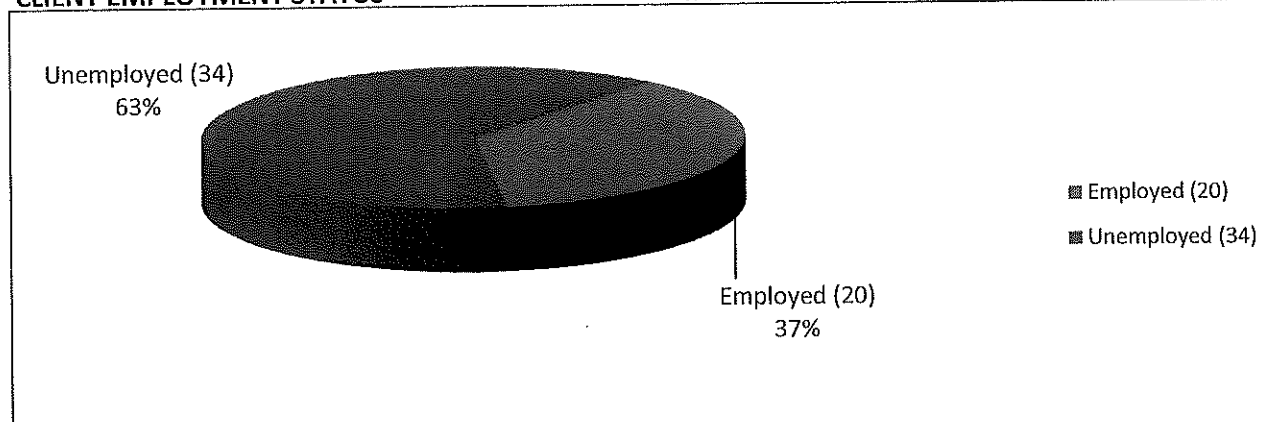

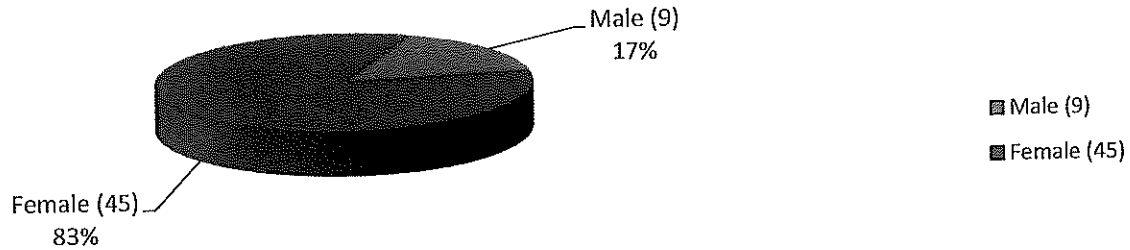

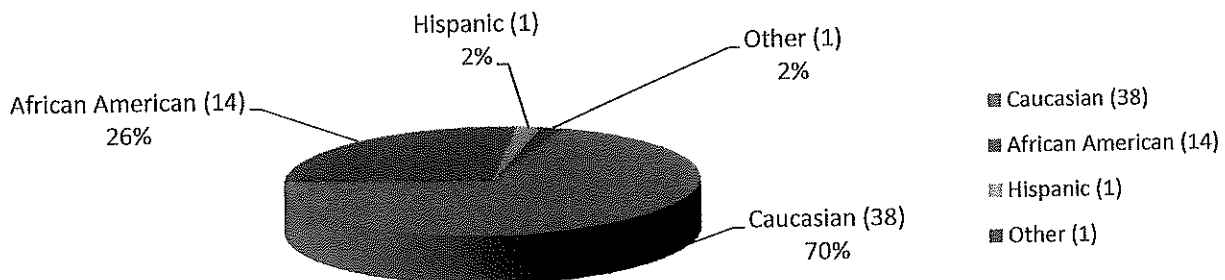

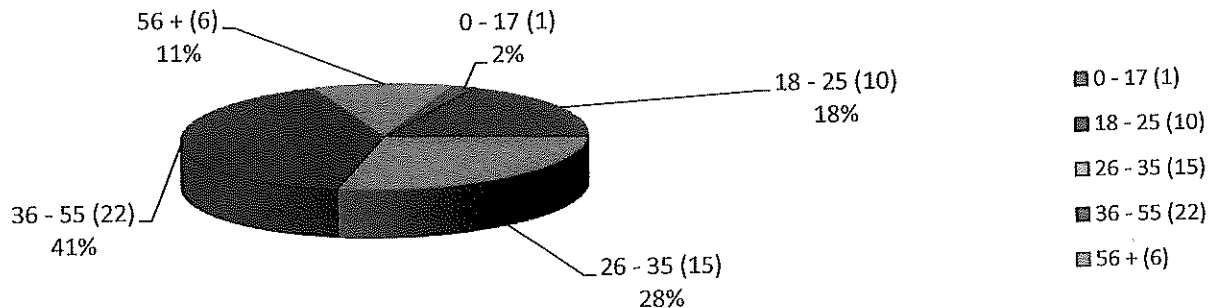

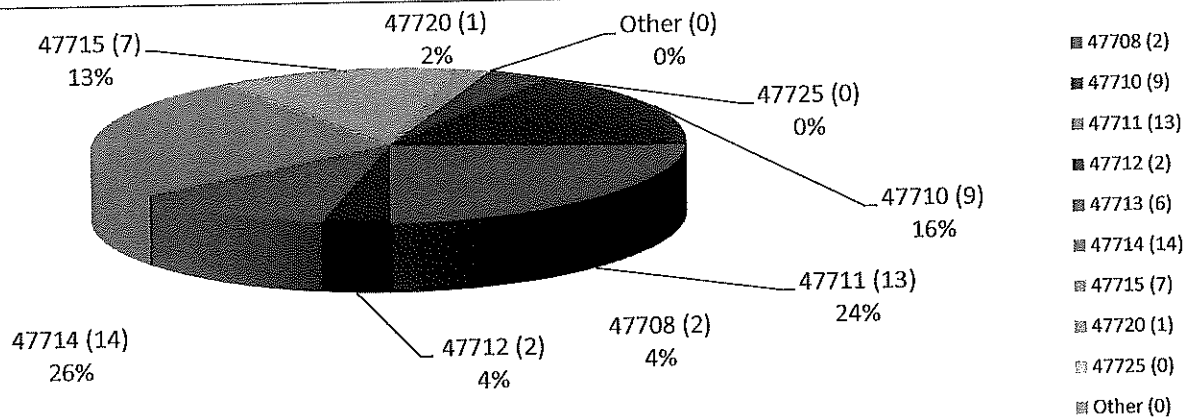

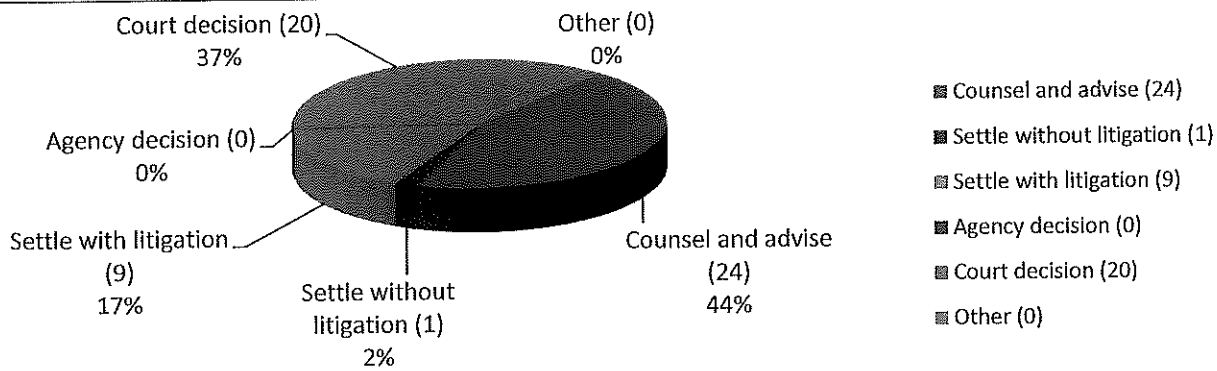

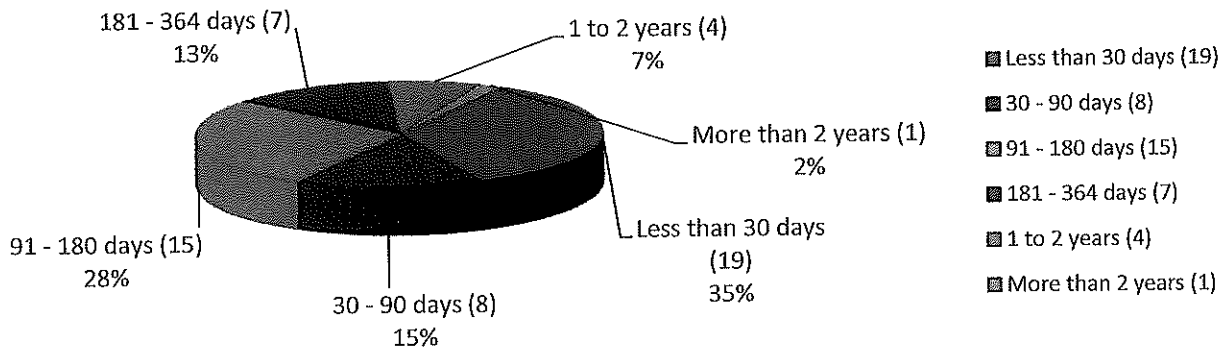
CLOSED CASES DISPOSITION

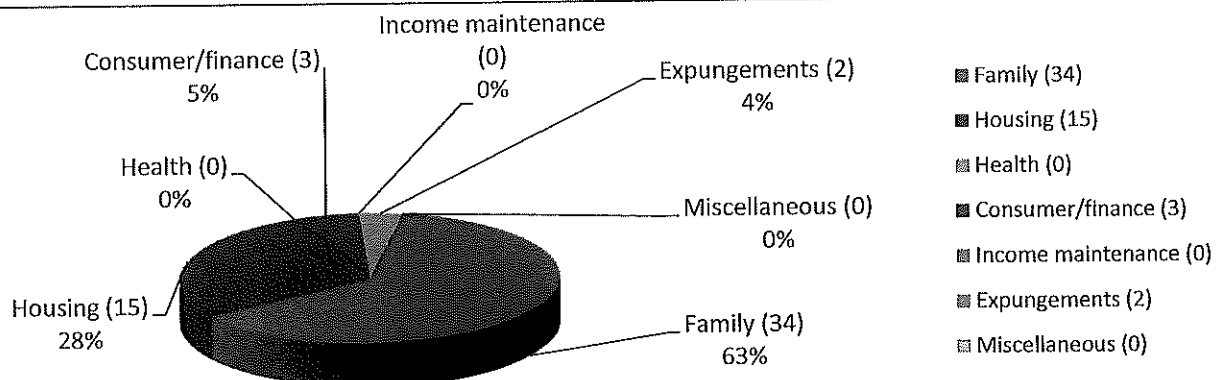
LENGTH OF TIME FILE WAS OPEN

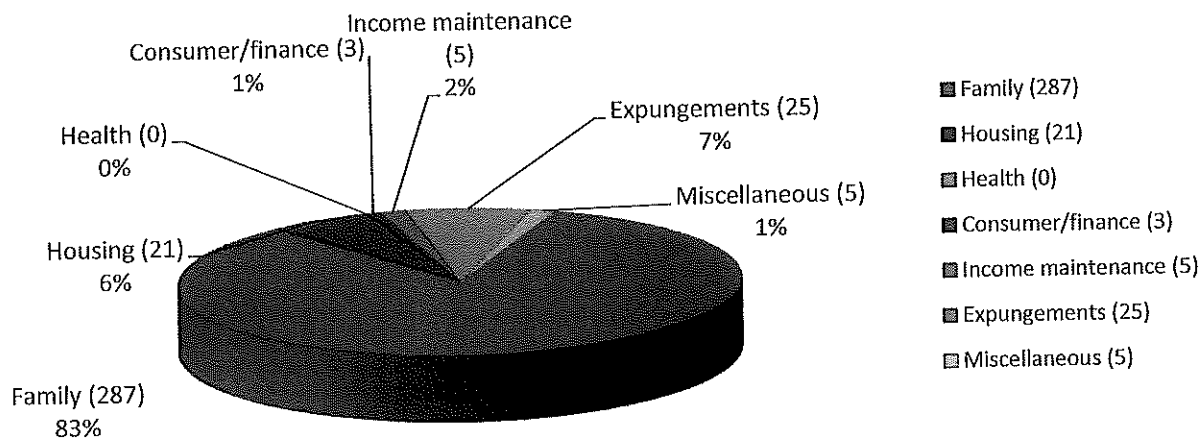

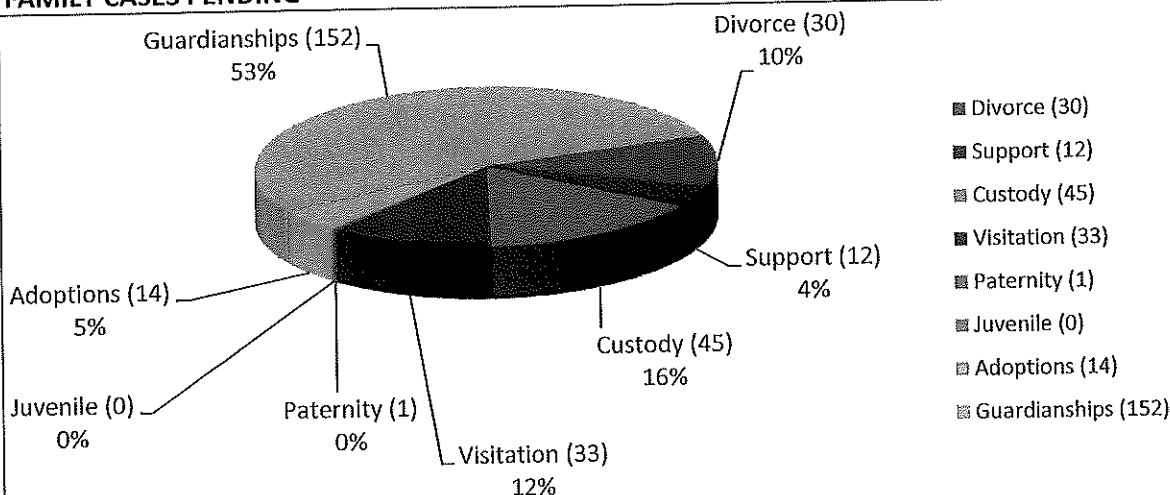
