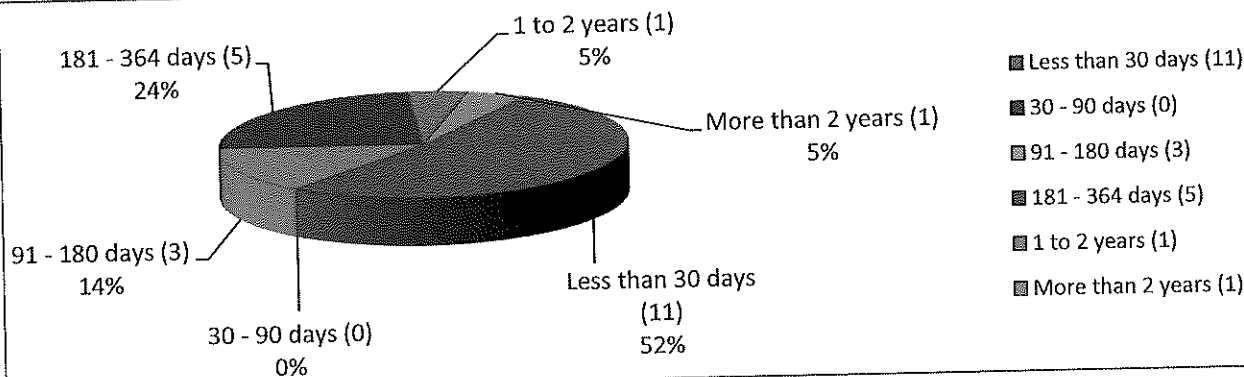
CLOSED CASES DISPOSITION

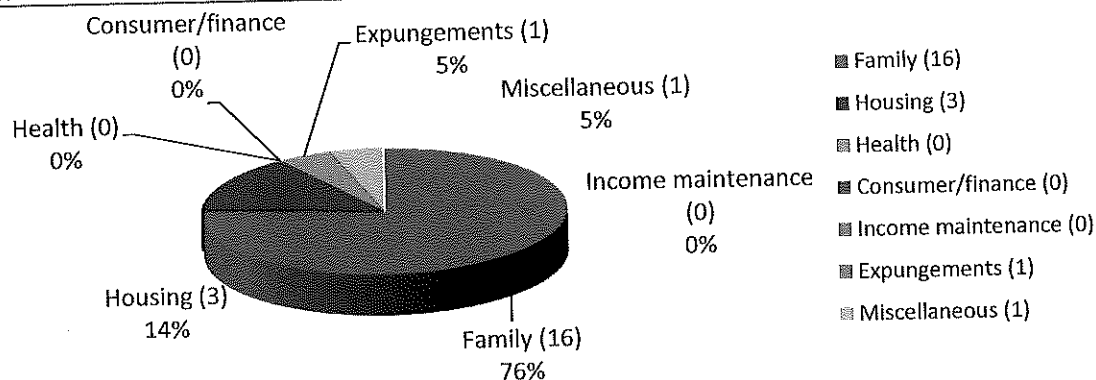
LENGTH OF TIME FILE WAS OPEN

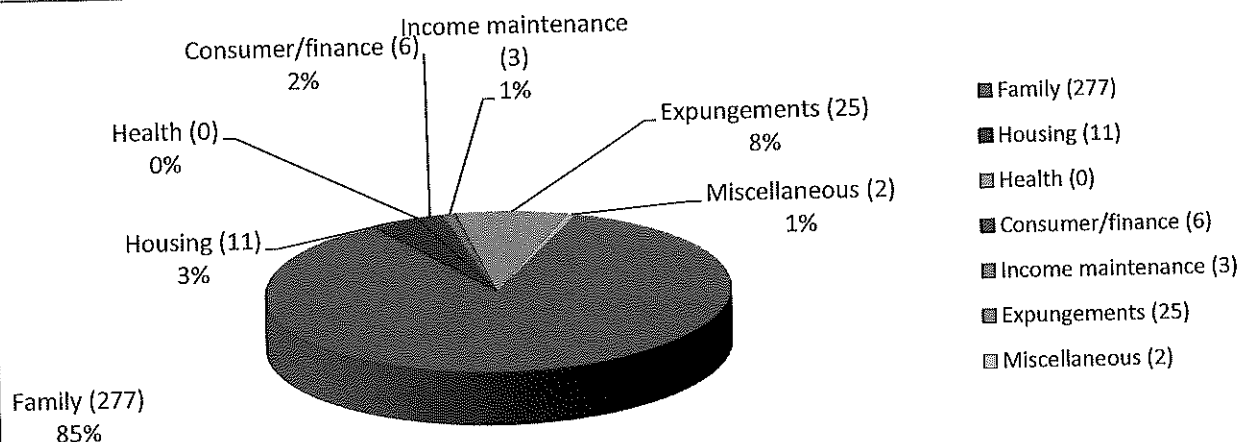

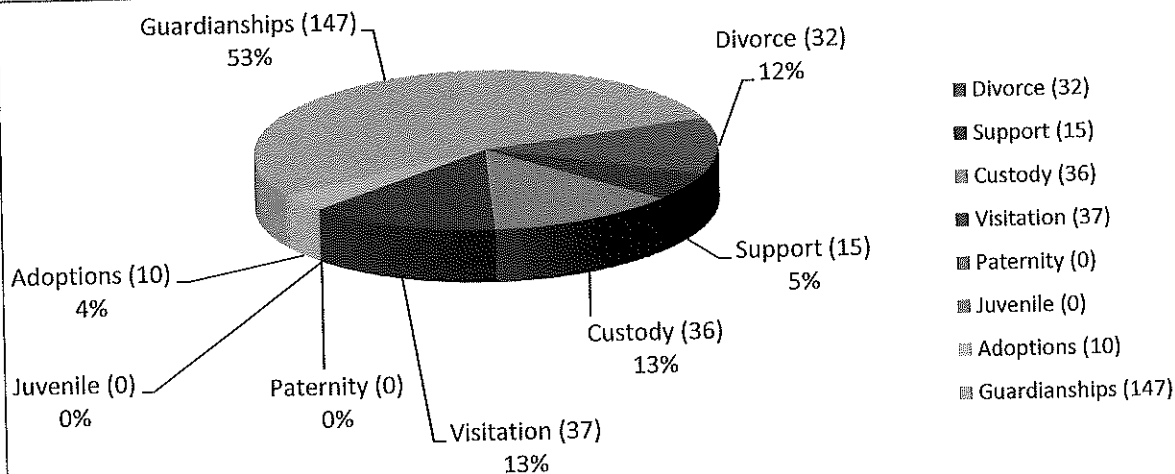
