The Vanderburgh County Board of Commissioners met in session this 13th day of October, 2020 at 3:01 p.m. in Exhibit Hall A of the Old National Events Plaza with President Jeff Hatfield presiding.

Reconvening of Meeting

President Hatfield: Okay, I'm going to reconvene the emergency meeting for the Vanderburgh County Board of Commissioners for October 13, 2020.

Attendance Roll Call

President Hatfield: Kathy, could you call the attendance?

Kathy Glaser: Commissioner Musgrave?

Commissioner Musgrave: Here.

Kathy Glaser: Commissioner Shoulders?

Commissioner Shoulders: Here.

Kathy Glaser: President Hatfield?

President Hatfield: I'm here as well.

Pledge of Allegiance

President Hatfield: If we could all stand for the Pledge of Allegiance.

(The Pledge of Allegiance was given.)

Permission to Open Bids for VC20-09-01: Concrete Street Repairs

President Hatfield: Up first on our action items was to open up some bids, but I don't think John Stoll is here yet. He had to wait for them over there at the Civic Center. So, we'll just wait for him to get back.

Remembrance of COVID-19 Victims

President Hatfield: The first item is a remembrance of COVID-19 victims. I'm going to hand this portion of the meeting over to Commissioner Musgrave.

Commissioner Musgrave: Thank you, President Hatfield. As of yesterday, we have had 42 deaths of Vanderburgh County citizens of COVID-19. This is a disease that didn't even exist at the beginning of the year, and it has now taken 42 of our friends and neighbors. I would just like to ask for a, just a moment of silence to reflect upon the loss of our neighbors, and also to thank the hospital personnel for all of their efforts, the entire medical community for everything that they have done to respond to this virus, and to their grieving families. I placed on my Facebook page three of the, three or four of the obituaries of these 42, and you can read the anguished love there for the loss of these three. Many of the obituaries did not reflect that their loved one was taken by this relentless virus. And, so, I cannot name those who also passed away from this, but I do want to remember them, and I want to emphasize that there are steps that each and everyone of us can take to avoid being a victim of this terrible virus. Wear masks, stay apart at least six feet, wash your hands nearly constantly, and you can also pray. So, Commissioner Hatfield, if we may just have a moment of silence.

President Hatfield: Yes.

(A moment of silence was observed.)

**Public Hearing/Final Reading of Vacation Ordinance CO.V-10-20-004:
A Petition to Vacate 140' of PUE at 10425 & 10445 Havenwood Meadows Dr.**

President Hatfield: Item C is a public hearing and final reading of vacation ordinance CO.V-10-20-004, This is a petition to vacate 140' of public utility easement at 10425 and 10445 Havenwood Meadows Drive. So, at this time I will open up the public hearing, and if there are any petitioners to come forward on, to make any remarks, I'll ask them to do so now. If you could, just state your name and address.

Jonathan Garvey: Jonathan Garvey, my current address is 2607 Beaumont Drive, Evansville, 47725. My wife and I, Amy Garvey, are the petitioners for the vacation of the public easement for the listed address of 10425 and 10445 of Havenwood Meadows Drive. We're just asking the Board to approve our ordinance to vacate that 140' of public utility easement.

President Hatfield: Okay, thank you.

Jonathan Garvey: Okay, thank you.

President Hatfield: Are there any remonstrators in the audience that would like to speak to this vacation? Seeing none. Do the Commissioners have any comments or questions regarding this?

Superior Court/Treatment Court: Employment Agreement with Jeanene Heldt

President Hatfield: Next up is Superior Court. This is an employment agreement with Jeanene Heldt, between the Vanderburgh County Superior Court Treatment Court and Jeanene Heldt.

Jodi Uebelhack: (Inaudible) she comes in on Tuesday and does the minutes for Treatment Court, and we pay her out of our User Fees. She's had the same agreement for seven years, and so Judge rewrote it to give her a slight pay increase, in line with what was given the other county employees.

President Hatfield: Okay. Could everyone hear what she just said? Just raise your hand if you heard every word she said.

Commissioner Musgrave: Just barely. It would be better if she just talked right into the mic.

President Hatfield: Okay, you know what, they clean that mic every time somebody, if you want to pull your mask down and just talk into the mic. I think that would really be helpful. I think we're far enough way.

Jodi Uebelhack: I don't have a problem taking my mask off. It's okay.

President Hatfield: Okay, okay.

Jodi Uebelhack: Jodi Uebelhack. I'm with Vanderburgh County Community Corrections. Jeanene Heldt is a retired Court Reporter for Vanderburgh County, and she comes in every Tuesday and does our minutes for Treatment Court. We have between 40 and 80 individuals each Tuesday that come in for Treatment Court, for the Judge to talk to them. Some of the are doing good, some of them are doing bad, but she puts minutes on it, and we pay her out of our User Fee account.

**Superior Court/Therapeutic Work Release:
Employment Agreement with Bailey Martin**

President Hatfield: The next one is an employment agreement with Bailey Martin, for a Residential Officer of Vanderburgh County Therapeutic Work Release from September 1, 2020 to December 31, 2021. Did I get that right?

Jodi Uebelhack: And, in line with our agreement with the union, Ms. Martin was a Residential Officer both in the jail and at the Therapeutic Work Release, and she moved on to another position. And, in line with our agreement with the union, we can employ her part time to do our filling in for people who take vacation and things like that, so we don't have to pay quite as much overtime. And, again, that money comes from grant money, or User Fees, it is not General Fund money.

President Hatfield: Okay.

Jodi Uebelhack: And, it is aligned with the contract with the union.

President Hatfield: Okay. Commissioners, do you have any questions?

**Superintendent of County Buildings: Spectrum Commercial
Right-of-Entry Agreement for Old Courthouse**

President Hatfield: Next on the agenda is Superintendent of County Buildings, the Spectrum commercial account right-of-entry. This is a right-of-entry agreement for Spectrum to install equipment into the Old Courthouse office. Commissioners, do you have any questions about this? I think there have been some e-mails from the Courthouse Superintendent on this. It's been weeks ago, but I personally don't have any questions.

Computer Services: WOW WAN Connections Relocation Agreement
--

President Hatfield: Next on the list is Computer Services. This is a service agreement to move county and joint department WAN connections to WOW. This is a service agreement. Mark, go ahead, you can describe it, if you like.

Mark Uhrin: Basically, we're moving our WAN Area Network on to WOW. This will occur over a period of months, ending with our termination of the contract with AT&T in April of next year. We expect to realize a savings of somewhere between \$60,000-\$70,000 a year in making this transition. So, we're looking forward to it, and ask your approval for the remaining. The first half has already been signed by the city.

Commissioner Musgrave: Motion to approve.

Burdette Park: Ford F-150 Truck Bids

President Hatfield: Next item is Burdette Park, for a Ford F-150 truck. Are we opening the bids for those? Or did—

Commissioner Musgrave: No, they already have them.

President Hatfield: Yeah, so these bids were all approved through the City-County Purchasing, as revised from earlier in the year, I think the County Legal Department. This will be funded through the 2020 Parks & Playground Capital line. This will complete our new purchase fleet and allow us to remove the final 1990 era vehicle from the park. I'm quite certain, I don't know this, but I know Jerry is pretty thorough. He's probably been through Council, County Council process there. Just, I'm assuming we just need to approve this, so they can move forward.

Auditor & Treasurer: XSoft INtax Property Tax Software Agreement

President Hatfield: The next item is County Auditor and County Treasurer, this is an X-Soft contract for property tax software services. The Auditor's Office and the Treasurer's Office, who are both with us today, are needing to upgrade their current tax software system. They've been, they have been with the current vendor since 2008, and, obviously, they would like to make a change on that. Commissioners, do you have any questions?

Commissioner Musgrave: I do not. I make a motion to approve.

County Engineer

President Hatfield: Is County Engineer, John Stoll, here yet? Oh, there he is. Go ahead. So, John, first on the list, if you want to just read down through there. Do you have the list?

John Stoll: Yeah.

President Hatfield: I can do it, if you don't want to.

John Stoll: I can take care of it.

President Hatfield: Okay.

John Stoll: The first item I have is a street acceptance request for Hornby Lane. This is in, the little segment of Hornby that was built in Creekside Meadows Subdivision. It's about 157' long, and it connects to the section of Hornby that was just paved by the County Highway Department. And, we're just requesting the Commissioners acceptance.

Commissioner Musgrave: So moved.

Commissioner Shoulders: Second.

President Hatfield: We have a motion and a second. And, Kathy, please call the roll.

Kathy Glaser: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Kathy Glaser: Commissioner Shoulders?

Commissioner Shoulders: Yes.

Kathy Glaser: President Hatfield?

John Stoll: Next I've got a street acceptance request for Magnolia Ridge Subdivision, Section 1. This is .67 miles of new roads, and the consist of Spanish Moss Boulevard, Persimmon Lane, Hibiscus Lane, Hemlock Lane, Verbena Lane, Lemon Grass Lane and Lemon Grass Court.

Commissioner Musgrave: Motion to approve.

Commissioner Shoulders: I will second the motion.

John Stoll: Next is a street acceptance request for Section of Poet Square Subdivision. This covers an acceptance of Reading Drive, Frost Drive, Shakespeare Drive and Watership Drive. The total mileage is .32 miles.

Commissioner Musgrave: Motion to approve.

Commissioner Shoulders: I will second the motion.

President Hatfield: Kathy, we have a motion and a second, please call the roll.

Kathy Glaser: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Kathy Glaser: Commissioner Shoulders?

Commissioner Shoulders: Yes.

Kathy Glaser: President Hatfield?

President Hatfield: I am a yes as well.

(Motion approved 3-0)

John Stoll: Next I've got a right-of-way offer for Boonville-New Harmony Road project. This is parcel 28 owned by Kiesel and Finney, and based on the appraisal, the offer amount is \$20,600, and I just need your approval to proceed with that offer.

Commissioner Musgrave: Motion to approve.

Commissioner Shoulders: Second.

President Hatfield: Kathy, please call the roll.

Kathy Glaser: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Kathy Glaser: Commissioner Shoulders?

Commissioner Shoulders: Yes.

Kathy Glaser: President Hatfield?

President Hatfield: I am a yes as well. The motion carries.

(Motion approved 3-0)

John Stoll: Last I've got a Community Crossings grant funding commitment letter. This is a letter that INDOT requires when we submit Community Crossings grants. The funding commitment on this letter is \$300,561.75, base on the estimates we've put together. And, this covers paving projects that would be on the Red Bank and Lloyd between Lloyd and just north of University Drive; Baseline Road between Azteca's entrance and U.S. 41; Rosenberger between the city limits and Hogue; all the subdivision streets in Key West Subdivision, which are Key West Drive, Largo Court, Upper West Terrace Drive and Summerland Court; and then all the streets in Ashton Place Subdivision, and those are Aster Lane, Sunflower Lane, Trillium Way, Oleander Lane and Allysum Drive. The due date for the applications is a week from Friday, and I just need the Commissioners signature on that. The funds would come from the Local Roads & Streets or Highway Contractual account in 2021.

Commissioner Musgrave: As we discussed earlier today, by e-mail I believe, are you also seeking permission to have a supplemental letter for a grant application, and do you want to describe any of that now?

John Stoll: I was going to bring that up in a second.

Commissioner Musgrave: Okay.

John Stoll: The estimates we've been putting together occupied all of our time, so we haven't had time to put together any concrete street patching contract cost estimates as of yet. So, I don't have an estimate, as of yet, and I don't have a Community Crossings grant application number, and those are the two pieces of information that I need in order to have another letter for your signatures today. So, I was also going to ask if the Commissioners could sign another letter, outside the meeting, for a second application. Because the county, technically, is eligible for up to a million dollars in Community Crossings money. This letter would give us \$300,000 in grant funds, combined with the \$435,000 that we received earlier this year, still leaves us with the ability to make another request. And, like I said, without the cost estimate information or an application number, I couldn't provide that letter today, but if you're allowed to sign one outside the meeting, I could come up with another one by the time the application due date rolls around next week.

Commissioner Musgrave: Well, I would like to make a motion to approve the letter that he does have, and the President to sign the letter that he will create when he gets it done before the deadline.

Commissioner Shoulders: I will second that.

President Hatfield: Kathy, we have a motion and a second. Was that it, John?

John Stoll: Yes. The—

President Hatfield: So, that's actually two things. Are you doing—

Commissioner Musgrave: One motion for two things, but it's really the same thing. He's going to do two applications (Inaudible. Talking over each other.)

President Hatfield: Can we do that, Craig or Dave? I guess (Inaudible). I want to make sure it's legal. Can we combine what just happened into one motion? Dave, are you on the phone?

David Jones: Yes, I am. Tell me again what he's wanting to do?

President Hatfield: Well, I think what happened was, you know—

Commissioner Musgrave: If you want, I can just split it up.

President Hatfield: Yeah, let's just split it up. Let's do that. Yeah.

Commissioner Musgrave: A motion to approve the application for the first set of roads that Engineer Stoll described.

President Hatfield: Yeah, so this motion is for the grant application—

Commissioner Musgrave: Letter that we have in the packet.

President Hatfield: Yes. Okay.

Commissioner Shoulders: Let's do that again. So, I will second the amended motion, or second the motion.

President Hatfield: Kathy, please call the roll.

Kathy Glaser: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Kathy Glaser: Commissioner Shoulders?

Commissioner Shoulders: Yes.

Kathy Glaser: President Hatfield?

President Hatfield: I am a yes as well.

(Motion approved 3-0)

President Hatfield: Now, John, restate what you said.

John Stoll: The second application would be submitted if you can sign a second funding commitment letter outside of a Commissioners meeting. I don't have any cost estimates, as of yet, and I don't have an INDOT grant application number, as of yet. And, those are the two pieces of information that are required in the funding commitment letter. So, since we're eligible for additional Community Crossings grant funds, I could put together another application between now and next Friday's deadline, subject to I would have to have the Commissioners sign off on the letter outside of a Commissioners meeting, since there won't be any meetings between now and the application due date.

President Hatfield: And, so this one is for like \$150,000?

John Stoll: It will be closer probably to \$250,000. What we're looking at was Brookview Heights Subdivision and Edinborough Subdivision. Those are two with some bad concrete streets that have generated a lot of complaints.

President Hatfield: Okay.

Commissioner Musgrave: Okay, motion to approve a second application, and to allow the President to sign the letter, as soon as Engineer Stoll completes it prior to the deadline.

Commissioner Shoulders: Okay, I will second that motion.

President Hatfield: Okay, Kathy, please call the roll.

Kathy Glaser: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Kathy Glaser: Commissioner Shoulders?

Commissioner Shoulders: Yes.

Kathy Glaser: President Hatfield?

President Hatfield: I am a yes as well.

(Motion approved 3-0)

President Hatfield: Is that it, John?

John Stoll: That's it. And, I did drop off the bids. Kathy has those, so, those are ready to be opened whenever you get a chance.

Commissioner Musgrave: Yes, I just made that motion.

President Hatfield: Yep.

Commissioner Shoulders: I'll second. I thought I did.

President Hatfield: Kathy, please call the roll.

Kathy Glaser: Commissioner Musgrave?

Commissioner Musgrave: Yes.

You know, since March, mid-March maybe early March, they've been working a lot of hours, doing a lot of great work, and I want to thank them for everything that they do. Any old business?
