That an order issued requiring garnishee defendant to appear in Court personally or answer interrogatories under oath concerning the wages, assets, income, profits, or other non-exempt property, due or to become due, to said judgment defendant, and return same to this Court on or before the date set out in said interrogatories.
3. That the Court after a hearing, issue an appropriate order to apply said property towards the judgment pursuant to statute.
