2020 Call for Projects

To Whom It May Concern:

The Evansville Water and Sewer Utility (EWSU) is seeking Green Infrastructure Projects for the 2020 Participation Program. Projects that are submitted will be scored and ranked by the selection committee. This year the available participation funding is up to \$1,500,000. Projects selected this year will be in the order they have been ranked. Only the top ranking projects will get participation funding this year.

Project submittals shall include the following:

- General Project Description
- Estimated Project Area
- Depth of Storm to be addressed
- Estimated Drainage Area Map to be Impacted
- Aesthetic Value to Community Long Term Public or Private
- Estimated Participation Amount
- Commitment to provide a Phase I Environmental \*
- Commitment to provide Design Plans in 90 days \*
- Commitment to provide Easements in 90 days \*
- Commitment to sign Grant Agreements in 90 days \*
- Commitment to start Construction within 180 days \*

*\* Commitments should be stated in writing with a signature and date*

More details on the EWSU Green Infrastructure Cost Participation Policy can be found on the website [www.ewsu.com](http://www.ewsu.com). In order for projects to be considered they have to be located inside the GI Participation area. The Green Infrastructure Opportunity Map is attached.

Proposals shall not exceed ten single-sided pages, including appendices. A one-page cover letter and divider sheets will not be counted within the ten pages. Please feel free to include any additional information that you feel would be beneficial to the selection committee.

Projects will be scored based on the following criteria:

- Total Acres and Volume Managed.
- Innovation
- Visibility within the wider community
- Aesthetics
- Feasibility, Maintainability & Durability
- Application Quality

Proposals are due no later than 3 P.M. Friday, April 17th, 2020  
Proposals will not be accepted if received after the time and date designated above.

The EWSU selection process will be used to select the successful Green Infrastructure Projects. All applicants that submit a proposal are expected to honor a "black-out" period of selection committee contact once proposals are submitted. All applicants that submit a proposal will receive notification of the results upon completion of the selection process.
