This schedule of rates and charges applies to **Evansville Water and Sewer Utility customers**, and supersedes previous schedules issued.

MONTHLY SERVICE CHARGE

The monthly service charge is based on meter size.

FIRE PROTECTION SURCHARGE

The **monthly surcharge** for fire protection is based on the meter size and the customer's location — inside or outside City limits.

COLLECTION OR DEFERRED PAYMENT CHARGE

Bills for water service not paid before the stated due date are subject to the collection or deferred payment charge of 10% up to the first \$3 of the delinquent payment, plus 3% for the remaining delinquent amount more than \$3.

VOLUME CHARGE

In addition to the monthly service charge, each user is **charged monthly for usage** according to this schedule.
