# First & Final Reading of Ordinance CO.07-21-010: Adding Section 2.90.345: Sexual Abuse Prevention Policy

President Shoulders: On to the people's business. The first action item is a first reading of ordinance CO.07-21-010, adding section 2.90.345. This is the sexual abuse prevention policy to chapter 2.90, the employee handbook of the Vanderburgh County code. Here with us today, we have Bob Dillow from Torian Insurance to speak to this item. Bob, the floor is all yours.

Bob Dillow: Thank you very much. I'm here today because I want to speak in support of a proposed amendment to the employee handbook, adding language regarding sexual abuse prevention. Your new insurer has recommended, and I should say demanded, that the current ordinance in place that establishes procedures for properly handling the administration of a county-wide abuse policy, should be updated. The insurer asked our agency to communicate with the leadership of the county to determine if there would be a willingness by the Commissioners to consider revising and updating the current policy. As you know, there was unanimous agreement among the Commissioners to do so. I would particularly like to thank David Jones and his team for their efforts in drafting the necessary language in the updated ordinance. I would also like to thank the Sheriff's Department, the Auditor and the Health Department for their help in obtaining the information necessary that was requested by the insurance company. And, lastly, Craig Emig yesterday suggested to me that it would be nice, since we're requesting this, if we would find a way to fund an administration or a loss control prevention meeting with department heads to do so. Craig, the insurance company has set aside \$5,000 to help in that endeavor. So, after this meeting, I would like to, in the next few days, communicate the beginning of how I recommend that that process should take place.

President Shoulders: Wonderful.

The State did tell us today that they're going to be providing us with data on who is not vaccinated in our county. So, that will be helpful too, just to know, you know, those people that we need to reach out to and try to provide those resources. So, that's kind of where we are with our vaccine. Everything is continuing with the Health Department. We're out every week and the hospitals, lots of different places you can get the vaccine here in Vanderburgh County. I think at one time I counted that it was over 50. So, with all the different pharmacies and different things like that, so.

And, our economic development teams are working on making a grant application for our region. The need for big ideas and transformational ideas is great. Final Reading of Rezoning Ordinance VC-5-2021
Petitioner: Kinjohn Properties, LLC
Address: 4430 & 4500 Proficient Court (Daylight Industrial Park)
Request: Change from M-2 to M-3
Action: Approved 3-0

President Shoulders: The only other rezoning we have today is a final reading of the ordinance VC-5-2021. This is a petition, the petitioner, I believe, is Kinjohn Properties, LLC. Oh, here you are. Donna is here to better explain.

Donna Holderfield: Donna Holderfield with the Area Plan Commission. Krista Lockyear on behalf of Kinjohn Properties, LLC is requesting to rezone the properties located at 4430 and 4500 Proficient Court from M-2 to M-3. On December 29, 2003 an Improvement Location Permit was issued for an 8,750 square foot storage warehouse. On January 6, 2020 an Improvement Location Permit was issued for four additional storage warehouses. The petitioner proposes to store explosives in part of the warehouses. The M-2 zoning district does not allow the storage of explosives. The storage of explosives is a permitted use of the M-3 zoning district. This proposed industrial zoning is consistent with the 2035 Future Land Use Map, which recommends this site for industrial uses. This is a request

to rezone the property located at 4430 and 4500 Proficient Court from M-2 to M-3 to allow the storage of explosives.

President Shoulders: Okay. Any petitioners? Oh, there you are. okay.

Krista Lockyear: I snuck up on ya.

President Shoulders: You did. You did. Okay.

Krista Lockyear: President Shoulders, Commissioners, my name is Krista Lockyear. I'm here on behalf of Kinjohn Properties. I also have with me Keith Kinney, who is a part owner of Kinjohn, and they are the property owners. This rezoning is a request for a new business to our county. The business name is Empire Wireline. They're a national company with facilities in Texas, Louisiana and Kansas. Their business involves servicing of wells, predominantly oil wells, water wells and I'm even told salt mines, but we don't have that around here, I'm not worried about that. In management of those wells, they need to utilize explosives in the field at times. They are governed by the ATF, and, so, this is an extremely safe facility. They will only store about 50 pounds of explosives on site, and they will be within an enclosed, metal, very secure container. When the explosives need to be taken out to a particular location, they're removed from that container, put into a smaller container that the mechanic can carry with him, and then taken out and detonated as necessary. I'm not an expert on explosives, but the expert from the proposed tenant has kind of given me a bit of an education and was at the Area Plan Commission giving some more details. Basically, these explosives are less than what a local fireworks store would have on site, but stored in a much more secure fashion. If the explosives were set off, the blast would be roughly 50 feet. If they were even set off outside of the container, it would be 100 feet. So, we're well away from any of our neighbors, building-wise, it's a pretty secure operation. So, we're asking to move from M-2 to M-3, simply to fit within the parameters of the building code, or subdivision code. I'm sorry, zoning code. If you have any other questions, I would be happy to answer them, or Keith can probably assist.

President Shoulders: Okay, any other questions for the petitioner?

Commissioner Hatfield: I think this passed unanimous at the APC?

Krista Lockyear: Donna, was it unanimous? I couldn't remember if we had an abstention, but Donna confirms yes.

Commissioner Hatfield: Okay.

President Shoulders: Okay, alright, I don't think we have any more—

Commissioner Hatfield: I'll make a motion for passage.

President Shoulders: Well, we don't have any, hang on, any remonstrators—

Commissioner Hatfield: Oh.

President Shoulders: --here today? Any remonstrators? Okay, now—

Commissioner Hatfield: I'll make a motion for passage.

Commissioner Musgrave: I'll second.

President Shoulders: I have a motion and a second. Madelyn, the roll call please.

Madelyn Grayson: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Madelyn Grayson: Commissioner Hatfield?

Commissioner Hatfield: Yes.

Madelyn Grayson: President Shoulders?

President Shoulders: And, I am a yes as well. The motion passes.

#### (Motion approved 3-0)

Krista Lockyear: Thank you.

President Shoulders: Thanks, Krista.

Reading of Bids: VC21 VC21-05-01: Concrete Street Repairs

President Shoulders: I think we have, well, yeah, public comment. Are you ready? Okay, we're going to do the bid opening first, before public comment.

David Jones: There were three bids for the concrete street repairs. The first bid, JBI Construction, Inc. The total for all roads was \$332.380.75, and that bid was in order. The second bid was Blankenberger Brothers, Inc. The total bid was \$372,700 even. That bid was in order. And, the third bid was Rivertown Construction, LLC, in the total sum of \$343,952.50, and that bid was also in order.

Commissioner Hatfield: What roads are those for?

David Jones: First is, the first section Bluegrass Road to Hillsdale Road to the dead end; second is Calumet Road, Bluegrass Road to the dead end; Hermitage Drive-Bluegrass Road to dead end; Lanes End Road to Hermitage Drive to dead end; Churchill Road-Birch Park Drive to Edinborough Road; Edinborough Road-Heinlein Road to Harlaxton Road; Harlaxton Road-King George Road to Edinborough Road; King George Road to Churchill Road to Harlaxton Road; Bob Court to Greendale Drive to Southport Drive; Windemere Subdivision, 2605 Waterston Drive, and Liberty Estates.

Commissioner Hatfield: Thank you.

Commissioner Musgrave: Motion to take the bids under advisement.

Commissioner Hatfield: Second.

President Shoulders: I have a motion and a second. Madelyn, the roll call please.

Madelyn Grayson: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Madelyn Grayson: Commissioner Hatfield?

Commissioner Hatfield: Yes.

Madelyn Grayson: President Shoulders?

President Shoulders: And, I am a yes as well to take the bids under advisement.

# **Public Comment**

President Shoulders: I think we had two people sign up for public comment. One was Jim Morley, Jr., but I think you've already....okay. So, Jim's already been covered. I believe we have Mr. Darrell McKnight here to speak to relief funds. Darrell, your name, organization and address please.

Darrell McKnight: Darrell McKnight, I'm actually representing my neighborhood. I live at 6694 Briar Court, it runs parallel with Pinehurst, and we share a sewer system, and it's made out of clay. When my family moved, I'll give you a little bit of background, when my family moved into Briar Court, no one told us that we were on a separate sewer system and it belonged to Old State Utility. Well, when we finally moved in and we got our water bill, we found out that we were paying them extra money. So, after five years, the city has

taken over the sewer system, and they were supposed to redo the whole sewer system. It was going to cost something like over a million dollars. Well, they got some sort of bid and they said the bid was too high. They did something out there, I have no idea really what they did. But, like I said, we've been paying extra money for the past five years, and this contract was supposed to go on for 20 years. We're averaging something like \$40-\$50 a month extra in sewage costs. It's my understanding, under the American Rescue Plan, the city got \$69 million and the county got \$32 million. I've talked to Alex Burton last night because the city was supposed to have taken over the water system, but he said come here and talk to you guys. What we're asking for is either give us our money back, because you guys got, the county got \$32 million, or let us off the hook for paying that extra money for the sewer system.

Commissioner Hatfield: I'll speak to this.

Darrell McKnight: Okay.

Commissioner Hatfield: I was appointed to the Utility Board by Mayor Weinzapfel back in 2001. And, then I spent another three years in Mayor Winnecke's first term on the Utility Board. And, I was on the Utility Board when we took over the sewer system in that area, because it was crumbling, and I do remember the residents being charged extra. I'm kind of shocked that its still nothing's happened, because I've been off the Utility Board about five years. And, who you need to petition directly is the Mayor's Office and the Utility Board. And, they pretty much own that sewer system. They took it over completely, they own it. The City of Evansville owns that sewer system. And, they should be spending part of their \$69 million on your sewer lines, or the utility should be bonding and improving your utility, or stop collecting money from you. One or the other.

Darrell McKnight: Well, like I said, I talked to Alex Burton last night, and I explained to him that you guys had taken over.

Commissioner Hatfield: I'm telling you it's the Mayor's Office and the Utility Board. The City Council has limited impact on this issue. I just know for a fact. You need to be in the Mayor's ear and get some relief on this issue. This is a very old issue. Those sewer lines are 40-50 years old. They were private, it was a private sewer system.

Darrell McKnight: Uh-huh.

Commissioner Hatfield: It was put in probably incorrectly. It's in horrible shape. It's been needing to have been replaced years ago. And, the whole purpose of collecting extra money from you was to bond it and improve it. And, so, the city and the utility needs to fulfill that promise and replace those lines.

Commissioner Musgrave: Commissioner Hatfield, could you explain to him how to get in front of the Utility Board?

Commissioner Hatfield: Well, the Utility Board, I don't know, they have to meet once a month. I don't know if they're still meeting on Tuesdays at 1:00 over there in the conference room there on the third floor as you get off the elevator. I don't know what room number that is.

Darrell McKnight: Probably 305.

Commissioner Hatfield: Yeah. You need to get a hold of Lane Young.

Darrell McKnight: Lane?

Commissioner Hatfield: Lane, L-a-n-e, Young, Y-o-u-n-g. The Mayor's Office might be listening to our meeting. They do, they monitor all meetings. It's not uncommon, and so they may be writing this down as we speak, and, but get a hold of Lane Young, he's the Director of the Evansville Water and Sewer Utility, or call the Mayor's Office and request to be on the agenda at the Utility Board. Contact the Mayor's Office, ask to speak to the

Mayor, he's a very open person. I'm quite certain he would probably take your call and try to help you.

Darrell McKnight: Well, that's where—

Commissioner Hatfield: But, the promise of the replacement of your sewer lines was made years ago. And, the beginning of collecting extra money from you started years ago. And, so, I agree with you that it's time for your sewer lines to be replaced. I was there when that happened. I knew exactly what you were talking about when you said where you lived. Those sewer lines need replaced, and, you know, I will certainly advocate to the Mayor, the next time I talk to him, that they need to replace those lines. The President of the Utility Board is Steve Heidorn. You can appeal to him. And, that promise was made to you guys, I don't know, six, seven, eight years ago.

Darrell McKnight: What I was told was that they, is that they didn't replace the sewer, but they lined it. I don't know—

Commissioner Hatfield: They put a lining in it, and that's an effective way of doing it, but not always. Not always.

Darrell McKnight: Well, that's the thing though, see, again, I hate to, you know, beat a dead horse, but they said that it was going to cost between one and two million dollars though—

Commissioner Hatfield: It doesn't matter. They're collecting money from you—

Darrell McKnight: Right.

Commissioner Hatfield: -- to replace those sewers. All they have to do is fit a bond that will fit the payments that they're receiving from you. It's done every day.

Commissioner Musgrave: Mr. McKnight? I would like to point out that the Mayor's Office is still open.

Darrell McKnight: That's what—

Commissioner Musgrave: So you could just walk right across the street, go up to the third floor and plead your case right then and there.

Darrell McKnight: That's where I'm going when I leave here. Thank you.

Commissioner Hatfield: Uh-huh.

President Shoulders: Thanks for your time, sir. Okay, I believe that's all the public comment we had today.

# **Adjournment**

President Shoulders: Unless anyone else has anything to come before this Commission, I ask for a motion to adjourn.

Commissioner Musgrave: So moved.

Commissioner Hatfield: Second.

President Shoulders: A motion and a second. Madelyn, the roll call please.

Madelyn Grayson: Commissioner Musgrave?

Commissioner Musgrave: Yes.

Madelyn Grayson: Commissioner Hatfield?

Commissioner Hatfield: Yes.

Madelyn Grayson: President Shoulders?

President Shoulders: And, I am a yes as well.
